INSTRUCTIONS: Please complete each line on this application including all information pertaining to your RV/Camper. The application must be entirely complete in order to be considered for the lottery selection process. Exterior photos of all four sides of your camper, a current registration, and proof of insurance must be attached with this application. A RV/Camper may only be entered into the lottery one time. Multiple applications with the same RV/Camper will result in disqualification. *Please note that completing this application does not guarantee your placement on a campsite. An approved application will enter you into the campground's lottery on the announced lottery date, specific sites are not guaranteed. Direct any questions to our park office at (423) 878-1881

SEASONAL SITE ELIGIBILITY

In order to be considered for a seasonal site, you must be able to meet the following requirements:

1. This application, all supporting documents and photos must be submitted for the application to be deemed complete and considered for approval.
2. You submit a legal, current, and valid registration along with proof of insurance when submitting this application. The registration and insurance must be in the name of the applicant/site holder(s). Ownership of an RV/Camper is required to apply for the seasonal lottery.
3. The RV/Camper must meet all campground requirements. The campground requires that all RVs and campers inside the park must be roadworthy and maintain roadworthiness the entire time that it is inside the park. The RV/Camper must appear clean and be fully intact, including windows, flooring, etc.
4. All seasonal site holders must be able to comply with TVA's Length of Stay Requirements. The TVA requirements can be found on our website at www.observationknob.com.

Once submitted, your application is good for the entire season and will be kept on file for each lottery held. If you were a previous Seasonal Site holder and was asked to leave the park for violation(s) listed: Failure to pay campsite fee timely, sanitary/litter violations, acts of violence, and violation of Observation Knob Park & Campground Rules, you may be denied a place in the lottery. All applicants will be approved or denied for the lottery by the Park Director. All campers must be 21 years of age or older to rent a campsite and/or occupy, adult presence required. Having someone else complete an application and participate in the lottery for you will disqualify you.

I/we understand that I may be asked to move (relinquish current campsite) to a different campsite, or to leave the campsite (and pay any owed debt to the park) if asked by park management. I understand that I/we may not be entered into the lottery. And if I do, I understand that I may not receive a campsite for seasonal campers/camping. I/we understand to notify the office of any address change and/or phone number change, or change in my RV/Camper. A RV/Camper change is subject to site size and allowance is the discretion of the Park Director. I certify that all information contained in this application is true and correct.
