**Automatic Payment Agreement** - This form authorizes Sullivan County Observation Knob Park, its affiliates and its and their successors and assigns (including by any servicing agent(s) of the account acting on their behalf) and any assignee of the account(s) to which this Agreement relates, ("Sullivan County Observation Knob Park") to set up automatic payment withdrawal for your Seasonal Account or to make a change to your existing automatic payment Agreement. By signing this Agreement, you authorize Sullivan County Observation Knob Park to make regular monthly deductions from the credit/debit card you provided to us on Page 1 of this Agreement and apply them as payments to your Seasonal Account. This Agreement replaces any prior automatic payment authorizations you may have provided. If this is a new authorization, keep making your monthly payments until the automatic payments begin. If this is a change to an existing authorization, we will continue to draw on the existing authorization until the date we begin taking your monthly payment under this authorization.

**For Seasonal Accounts:** 1) The deductions we make from your credit/debit card will be applied as payments to your Seasonal Account each month in the amount of the regularly scheduled payments and on the due date as specified in your Seasonal Contract agreement or other due date agreed upon by you and Sullivan County Observation Knob Park. 2) If a due date falls on the 29th, 30th, or 31st of a month and that date does not occur in that month, the due date will be adjusted to the last day of that month. 3) If your due date falls on a weekend or a holiday, we'll deduct your payment the next business day (Business days are Monday through Friday, excluding federal holidays). 4) We won't process your deduction if there's nothing due on your account on the business day prior to your due date (for example, if you already made the full payment some other way). 5) We may bill you separately for certain fees or charges on the Seasonal Account. 6) Your account must be current to enroll in automatic payments.

**Additional information for seasonal accounts:** 1) The monthly deduction amounts for seasonal accounts will not vary. Should your account acquire fees or other charges, you will be responsible for making these payments manually. Failure to do so can result in additional fees. You'll stop receiving a monthly statement and each month's deduction will be in the amount of the monthly payment specified in your Seasonal Account agreement. You can view electronic statements by requesting them at the park office, 553 Knob Park Road, Bristol, TN. 2) This Agreement will automatically expire when we receive your last scheduled payment on your seasonal account.

**Returns:** If your credit/debit card company/bank sends us a returned payment for whatever reason, Sullivan County Observation Knob Park may reverse the payment made to the Seasonal Account and you will be responsible for any late fees and/or returned payment fees, including fees acquired to us by our Merchant. If a deduction causes an overdraft of your Bank account, your Bank may assess an overdraft fee or refuse to honor withdrawals. If your Bank returns more than one automatic payment, Sullivan County Observation Knob Park has the right to terminate this Agreement and future automatic payments. Failure to exercise this right is not a waiver of the ability to do so at a later time.

**Cancellation/Termination:** Sullivan County Observation Knob Park can terminate this Agreement at any time with notice. You may cancel this authorization at any time by notifying Sullivan County Observation Knob Park at least three business days prior to the date that you'd like the cancellation to be effective. You can cancel by visiting the park office or by U.S. mail at Observation Knob Park, 553 Knob Park Road, Bristol, TN 37620. You can also call us to cancel or to ask questions at 423-878-1881, Monday through Friday, from 8:00 a.m. to 4:00 p.m., Eastern Time (IN SEASON HOURS MAY VARY).
