

## Strategic Executive Solutions (SES)

### Executive Summary:

Strategic Executive Solutions, a part of the ARIS ZINC GROUP, was tasked with providing the necessary expertise to establish medication management within the Electronic Medical Record (EMR) system for Bendigo Health. This project was in line with the development of the largest regional hospital in Victoria, the Bendigo Hospital Project, which would cater to over 300,000 people.

The Strategic Executive Solutions consultant worked closely with Bendigo Health, defining the scope of medication management in the EMR system, reviewing hospital policies and procedures, and liaising with regulatory authorities regarding legal issues in relation to electronic prescribing. They recommended appropriate decision support and clinical workflows for electronic prescribing, defined patient-related information and notification for patient medication alerts, assisted in defining medication orders for clinicians, developed standard order sets and order favourites, implemented the hospital formulary within the EMR, defined medicines reference material for duplicate therapy, drug-drug interactions, and drug dosage, reviewed equipment requirements for medication dispensing and drug administration, and assisted in developing discharge medication protocols.

The new facility has the capacity for 372 inpatient beds, 72 same-day beds, 11 new operating theatres, an integrated cancer centre, an 80-bed psychiatry services facility, a parent-infant unit, a helipad, and a multi-deck carpark.
