## **Strategic Executive Solutions (SES)**

## **Executive Summary:**

Strategic Executive Solutions (SES) was selected to provide Digital Transformation, Strategic, and Program Management expertise for the Rural Councils Transformation Program (RCTP) Grants, which was a \$20 million funding initiative by the Victorian Government to encourage large-scale transformative projects on a regional level.
