




# **Ready for take-off?**



# Study at the beautiful Gold Coast, just a few hundred metres from the beach and right next to an international airport.



# Fees are based on 2019 annual tuition fee and will be subject to change.

The Bachelor of Business develops the practical skills for decision-making and the capability to recognise and act on opportunities. First year includes foundational business units in law, accounting, economics, management, marketing and statistics.

In second year, students complete two Airways Aviation courses approved by the Civil Aviation Safety Authority (CASA). The Diploma (CPL) comprises of two pilot licence types Private Pilot Licence (PPL), and Commercial Pilot Licence (CPL). The Diploma (IR) offers advanced flight training conducted on a multi-engine class aeroplane.

In third year students return to Southern Cross University to complete their studies in strategy, entrepreneurship and a focus on aviation management.
