I, the undersigned _____, (name of additional undersigned if principal is minor {legal guardian name} _____) do understand that by being present on these environs, a working farm, hereto referred to as **Dawn Gilbert Show Horses, LLC**, or Trainer, that I am hereby considered an equine activity participant.

INHERENT RISK AND ASSUMPTION OF RISK. As an equine activity participant, I acknowledge there are inherent risks associated with equine activities and hereby expressly assume all risks associated with participating in such activities. These inherent risks may include, but are not limited to, the risk of bodily injury, property damages, or death. The propensity for equines to behave unpredictably in such ways including, but not limited to- bucking, rearing, kicking, striking, biting, stumbling, bolting, spooking, shying; reacting suddenly and violently to unfamiliar objects, motions, sounds, persons or other animals, environmental hazards such as wind, snow, or ice- either stationary or falling, can result in harm or death to property, persons or other animals on or around them.

I, (initial)_____ acknowledge that I have read the posted warning sign, LOCATED: on entry door to riding arena, that identifies the inherent risk(s) of the on-farm activities in which I will be participating- activities that may expose me to the risk of personal injury, death or damage to my property.

The Visitors Responsibility Sign is LOCATED: on wall in short aisle to the arena. This sign describes my responsibilities as a visitor to a working farm, which includes, but isn't limited to; obeying directional and "off limits" signage, following instructions and obeying warnings from farm representatives, complying with posted rules of conduct, and exercising reasonable care concerning disclosed risks.

I (initial)_____ acknowledge that I understand all the information contained in the Warning to Visitors, and Visitors Responsibilities signs, or have asked for clarification prior to signing this form and starting my on-farm equine activities.

I additionally acknowledge that if I am accompanied by someone who needs help in understanding the inherent risks (guardian of a minor, or otherwise) of participating in on farm activities or the responsibilities of a Visitor on a working farm, I have asked a farm representative to explain to those people the risks and responsibilities so that they (additional Visitors) may also understand them. IF I (or those I am with) ARE UNPREPARED OR UNWILLING TO ACCEPT THESE DISCLOSED RISKS AND RESPONSIBILITIES IMPOSED ON A VISITOR TO A WORKING FARM I WILL ADVISE A FARM REPRESENTATIVE BEFORE IMMEDIATELY EXITING THE PROPERTY. No further services or charges will be rendered by Dawn Gilbert Show Horses, LLC at that time, except as necessary to maintain care, custody and control of any equines left in their care.
