Founded by Minister Derek Francois, a formerly incarcerated man transformed by faith, LCPM exists to restore dignity, rebuild lives, and reconnect families through the power of the Gospel and comprehensive reentry support.

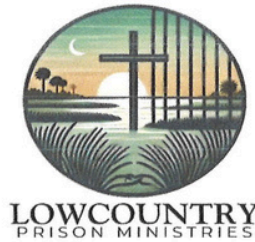

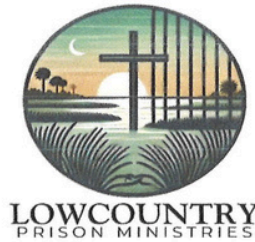
