Application fees and assessment fees:

- The application fees are listed above. The application fee covers one year of accreditation and is an annual fee. The application fee for ISO/IEC 17020 may include ASTM E329, if desired.
- Assessment fees apply for the initial assessment (before granting accreditation), follow-up assessment, if deemed necessary, and re-assessments (starting every year after the initial assessment). Assessment fees include \$950 per 8-hour day per assessor for on-site assessments, \$750 per 8-hour day per assessor for travel time, and other related travel expenses (at cost). Assessment fees are based on your agency's location and scope of accreditation.

CONDITIONS FOR APPLICATION

- a. As a condition of the accreditation, the applicant acknowledges that CMEC, staff or authorized representative(s) may conduct unannounced assessments of the facilities of the applicant, or other facilities where the applying agency conducts inspections under this application, to verify compliance with the listing and applicable rules of procedure.
- b. Applicant shall reimburse CMEC within 30 days for all expenses related to accreditation. Reimbursable expenses include, but are not limited to, travel expenses and staff time.
- c. A CMEC special inspection agency accreditation does not imply any guarantee or warranty, express or implied and including but not limited to any warranty of merchantability or fitness for any particular purpose, of any product inspected or certified by the applicant, or any guarantee or warranty of any nature by CMEC concerning any inspections conducted by the applicant. Applicant acknowledges and agrees that the authority to recognize an individual or entity as a special inspector rests solely with the building official of the jurisdiction in which the applicant seeks such recognition. Applicant agrees that it shall have no cause of action or claim against CMEC, or the officers, directors, members and employees thereof (collectively, the "Indemnitees"), arising in any manner in connection with CMEC special inspection agency accreditation or an application for CMEC special inspection agency accreditation or renewal thereof, including without limitation from any denial or delay of this application or from any accreditation given pursuant to this application, whether or not such accreditation is or is not subject to any conditions, or from applicant's failure or inability for any reason to obtain special inspection agency accreditation. Applicant agrees to hold the Indemnitees harmless, and to protect, defend and indemnify them, with respect to any claim, liability, demand, action, judgment, proceeding, costs, damages and expenses (including attorneys' fees) whether for personal injury, wrongful death, property damage, or any type of injury or damage whatsoever, arising from: (i) the application and accreditation; (ii) any CMEC special inspection agency accreditation or an application for CMEC special inspection agency accreditation; (iii) any certification or inspection services of any nature provided by the applicant; (iv) the use of any service of any nature offered by the applicant, or the use or operation by any person of any product inspected or certified by the applicant, whether related to the matters set forth in the first sentence of this paragraph or otherwise; or (v) the reference to or reliance upon, actual or asserted, any product certification or approval given by the applicant or any inspection services rendered by the applicant including but not limited to the results of any inspections conducted by the applicant. If any part or portion of this paragraph, or any application thereof to particular facts, should be determined invalid, the provisions hereof shall be severable so as to achieve for the Indemnitees the maximum legal application. If this application relates to a branch special inspection agency listing or a renewal of an existing accreditation, the provisions of this paragraph shall apply from the date of the first granting of the branch special inspection agency listing, whether upon application or without application by applicant or a predecessor and regardless of: (i) intervening modifications of said listing or modifications pursuant to any application for renewal; (ii) any prior change in the number assigned to the listing; (iii) any prior change in ownership rights in or rights to said listing, or any branch special inspection agency listing, whether one or more, since the granting of said first branch special inspection agency listing.
- d. In consideration of the processing of this application, the applicant agrees to abide and be bound by any conditions attached to any listing or renewal thereof issued pursuant to this application, or any later amendment of said listing or renewal, the Rules of Procedure for Special Inspection Agency Accreditation, which by this reference are made a part hereof, the Accreditation Criteria for Special Inspection Agencies, which by this reference is made a part hereof, and any additions, deletions, or changes to such Rules or Accreditation Criteria hereafter adopted.
