Security and Safety Alert

It's unfortunate but our neighborhood has had several instances in November that required the Livingston Parish Sheriff's Office to be called. Several residents reported eggs being thrown at their cars when entering the neighborhood. Also reported were a home and car being egged. In addition, several residents reported their doors and/or windows being knocked on in the evening hours, some being inside a fenced yard. We're thankful for our neighborhood's

Facebook page as it was the first place these instances were reported which helped in alerting other residents. It's also been learned that Pecan Creek has experienced some of the same issues.

The Association will have a Security Committee for 2017. If anyone sees any suspicious activity or person in our neighborhood, please do not hesitate to report it to the sheriff's office, no matter how big or small.



Alligators have been reported being seen in the pond towards the back of the subdivision. The Louisiana Department of Wildlife and Fisheries has a Nuisance Alligator Program. Please visit their website at

FIREWORKS SAFETY TIPS

Here are safety tips from the National Fireworks on Safety Council.

- 1. Obey all local laws regarding the use of fireworks
- 2. Know your fireworks; read the cautionary labels and performance descriptions before igniting.
- 3. A responsible adult should supervise all firework activities. Never give fireworks to children.
- 4. Alcohol and fireworks do not mix. Save your alcohol for after the show.
- 5. Wear safety glasses when shooting fireworks.
- 6. Light one firework at a time and then quickly move away.
- 8. Use fireworks outdoors in a clear area; away from buildings and vehicles.
- 9. Never relight a "dud" firework. Wait 20

- minutes and then soak it in a bucket of water before you discard it.
- 10. After purchasing fireworks, always store them in a cool, dry place.
- 11. When using fireworks always have a connected hose, bucket of water, or other water source nearby.
- 12. Never carry fireworks in your pocket or shoot them into metal or glass containers.
- 13. Do not experiment with homemade fireworks.
- 14. Dispose of spent fireworks by wetting them down and place in a metal trashcan away from any building or combustible materials until the next day.
- 15. Ensure all pets and animals are away from fireworks noise.
- 16. With the rise in stress-related disorders affecting American service men and women, pay special consideration to individuals who may be sensitive to loud noises in proximity to your fireworks show.
