

# **Integrity Policy**

#### Introduction

Pinnacle FC Inc. is committed to fostering an environment of trust, fairness, and respect within the organization. As a club, we recognize the importance of maintaining the highest ethical standards in all our activities and interactions. This Integrity Policy sets forth the expectations for conduct, responsibility, and accountability for all players, coaches, staff, volunteers, and supporters of Pinnacle FC.

- Directly to the Club's President, Vice President, Secretary or Treasurer (The Executive Committee).
- Email submission to the club's official email address.
- Anonymous reporting options (if available).

#### 2. Whistleblower Protection

Pinnacle FC protects individuals who report concerns about unethical or illegal activities from retaliation. Anyone who feels they have been retaliated against for making a report should immediately contact the Integrity Officer or the Club's President.

## **Disciplinary Action**

Any individual found in violation of this Integrity Policy may be subject to disciplinary action, up to and including:

- Verbal or written warning
- Suspension from club activities or events
- Expulsion from the club
- Legal action (if necessary)

Disciplinary decisions will be made fairly and impartially, based on the severity of the violation.

Pinnacle FC is committed to maintaining and continuously improving the integrity of the club. Regular training, workshops, and awareness campaigns on ethics and integrity will be held for all members to ensure ongoing adherence to these standards.
