

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to e-commerce website, and Heavenly Touch for Natural Hair and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Heavenly Touch for Natural Hair include heavenlytouchedhair.com and Heavenly Touch. The Heavenly Touch application is a e-commerce application. By using the Heavenly Touch application, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, Heavenly Touch may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Purchase Order Details

If you purchase Heavenly Touch's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Heavenly Touch may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. ### **Sharing Information with Third Parties**

Heavenly Touch may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Heavenly Touch, and they are required to maintain the confidentiality of your information.

Heavenly Touch may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Heavenly Touch or the site; (b) protect and defend the rights or property of Heavenly Touch; and/or (c) act under exigent circumstances to protect the personal safety of users of Heavenly Touch, or the public.

### **Security of your Personal Information**

Heavenly Touch secures your personal information from unauthorized access, use, or disclosure. Heavenly Touch uses the following methods for this purpose:

- Godaddy Secure SSL

### **Right to Deletion**

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

### **Children Under Thirteen**

Heavenly Touch does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this application.

### **E-mail Communications**
