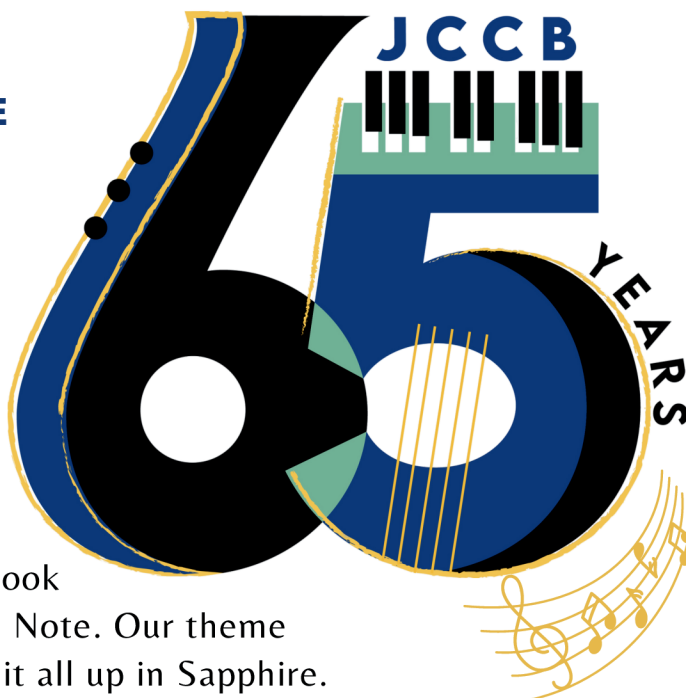

JCCB : STATS & FACTS

Our recipients are children, single moms, veterans, survivors of domestic abuse, working adults and neighbors seeking employment ... families like ours that never thought they would need help.

Over 36,000 Johnson County neighbors live below the federal poverty level (6.5% of the population).

The total number of people living in low-income housing is 90,341 or approximately 15% of the Johnson County population. We estimate that an additional 25,000 neighbors live below 150% of the federal poverty level. In 2024, we served over 13,000 of our neighbors.

For a family of four, this is an annual income below \$37,650.00. These families need a bridge to help them properly provide for their children and pay their bills. JCCB is that bridge.

Since 1960, JCCB provides warmth and support, during the winter holiday season to low-income Johnson County, Kansas families. Our annual Holiday Shop allows families in need to "shop" for children's & teen coats, toys & gifts, clothing, personal care items, hats & gloves, books as well as groceries, all at no cost. We increase awareness and understanding of poverty in Johnson County, Kansas; and give neighbors an outlet to help neighbors.
