VIOLATION FINE SCHEDULE

October, 2020

By unanimous vote, The Lookout Pointes Board of Directors ("Board") has elected to institute a fine system for repeated violations of neighborhood regulations. While the goal is for all residents to be in compliance **without** having to assess fines, due to continual violations, the following violation fine schedule has been adopted in order to help protect the neighborhood's property values, appearance, safety, and quality of life.

A written warning will first be sent to the homeowner/member of the infraction; which will include a grace period to resolve the issue to avoid a fine, or will let them know if the violation occurs a subsequent time a fine will be imposed. The written warning and all communications will be sent to the homeowner's/member's address on file with the Lookout Pointes Homeowner's Association, Inc. or its agent. Appeals may be made in writing to the Board, which reserves the right to exercise discretion in administering the fines, within fifteen (15) days of date of the notice of violation.

Lookout Pointes is a neighborhood in which we have all chosen to live. We are neighbors who make one community. If an issue arises, remember to treat your neighbors kindly and work together to resolve the issue. However if the issue cannot be resolved or you feel it is more appropriate for a third party to address the matter, the Board is available to assist.

Pursuant to the documents identified below, the Board reserves the right to engage legal representation to enforce collection of fines and to correct/address the underlying violations; the cost for which will be charged to the property/home owner as set out in the documents identified below

- Exterior Maintenance Violations with 20 Days to Correct Prior to Issuing Fines:
 - Removal of dead tree posing a safety hazard

\$25 per day

 Aesthetic neglect of house (e.g. need of paint, exterior cleaning, or repair) and/or yard (e.g. dead/overgrown flower beds, failure to maintain lawn)

\$25 per week

- Fines to first be taken from New Construction Compliance Security Deposit:
 - New construction work not completed within one year from date of commencement

\$500 per month

 Failure to remove new construction debris/trash, and failure to manage storm water/silt/mud runoff

\$500 per incident plus the costs to remedy
