*Trans Track Athlete Sues Princeton After Losing Spot in Invitational*

*Sadie Schreiner, a transgender woman and track and field athlete, is suing Princeton University, alleging discrimination after she was removed from the start list of the women’s 200-meter run at the Larry Ellis Invitational in May.*

Schriner qualified for the event based on previous official times as an “unattached athlete” but was informed 15 minutes before the race she could not run because she was transgender. Schriner, a biological male, was a Division III All-American sprinter on the Rochester Institute of Technology women’s track team in 2024. [Ref: Addenda #4 – March 2025]

*Trans volleyball player incident unleashes parade of angry parents on Illinois school board meeting*

*Anonymous parent says daughter broke into tears on first day of school after finding out she didn't make the team, while a trans athlete did make it*

Angry parents spoke out at a school district board meeting, in protest of a 6-foot-4 biological male who had never played volleyball before making the Conant High School girls volleyball team. An anonymous parent told reporters that her daughter was cut trying out for the team while the male student made it, but that the trans athlete quit the team the very next day amid the controversy. Another parent told reporters that the girls volleyball coach quit her position after being forced to allow the male – who is also allegedly using the girls' bathroom and locker room facilities, according to parents – on the girls' team. , "It's not a girl's responsibility to feel uncomfortable or unsafe for the sake of a boy pretending to be a girl! He should be participating in sports designated for boys because he will always be one!" Conant High School is now in violation of President Trumps Executive Order regarding biological sex vs. gender identity, as the unnamed student regularly used the girls bathrooms, locker room and shower facilities in the school.

*Va. AG says Roanoke College discriminated against female athletes by allowing trans swimmer on team*

*Roanoke College has been found in violation of state and federal civil rights laws, Virginia Attorney General Jason Miyares announced Monday, citing discrimination against female student athletes.*

*The findings come after the institution “retaliated” against multiple female swimmers for speaking out against the private liberal arts college, according to the AG’s office, for allowing a transgender woman athlete to compete with them in August 2023.*

In October 2023, the captains of the sophomore, junior, and senior women's swim squads at Roanoke College — Kate Pearson, 19, Lily Mullens, 20, and Bailey Gallagher, 21, went public with the story that a biological male who competed for the men's swim team at the college in 2022, was now a member of the women's swim team. "I never expected to be blindsided by a teammate from the men's team who now wanted to compete against me and my fellow swimmers and shatter our records," Gallagher said. The trans swimmer, who all the girls knew as male prior to his transition, said they were made to feel guilt and blame for not being inclusive and welcoming him onto the women's team. Pearson said at the news conference, "Every time we tried to speak up about our feelings we were either shoved aside or expected to deal with all of our concerns ourselves. We felt completely ignored by our school — a place that is supposed to be our home away from home... Our feelings, the team's feelings and comfort were blatantly ignored and only one athlete was prioritized. I felt unheard and unseen. Our comfort was undervalued and discarded."

The three captains held a meeting with the rest of the swimmers, who all agreed that although they supported the persons right to transition, they did not want him to compete with them. "We support you... But when it comes to the athletic side of things, we just think it's biologically unfair." In answer to their concerns about having a biological male, with intact male genitalia sharing locker-room and shower facilities with them, the women swimmers were told by the college they had to stand by the transgender swimmer, because she (he) felt suicidal because of the efforts to oust him. The biological male swimmer quit the swim team after deciding he did not want the attention and scrutiny that would result from the press conference.

Virginia Attorney General Jason Miyares said that Roanoke College has been found in violation of state and federal civil rights laws, due to their discrimination against female student athletes. The allegations are that the coach, athletic director and the college's administration ignored the women's objections, kept the swimmer, and refused to change its policy. The female swimmers said they faced retaliation from the college and an unspecified educator, which denied their applications for a study-abroad program.

"Women deserve an equal opportunity to participate in competitive sports," Miyares said in a statement on Monday. "That opportunity is protected by state and federal law."
