Ch. 12 A New Form of ‘Fascism’ for the 21st Century  
Americas “Threats” Against Tyranny and Fascism

Preface:

*This is not a partisan promotion of the greatness of Donald Trump! Although I voted for him in the past three elections, and support and approve of most of his agenda, this is a story about how those in power, who had everything to lose, mounted a campaign against the one man who was the greatest threat to them achieving the agenda they put forward; The Great Reset.*

At the beginning of each Clear and Present Danger “Threat” publication, I made the following statement:

*In my view, there are three distinct threats to our individual liberties and freedom today. Progressive Democrat Marxism, the United Nations global Agenda 21 AND, The Great Reset.*

So, what exactly is *The Great Reset*? In a June 2020 announcement, the World Economic Forum (WEF) gave the world the answer to that question in an article titled, *Now is the time for a ‘great reset’*

*“COVID-19 lockdowns may be gradually easing, but anxiety about the world’s social and economic prospects is only intensifying... To achieve a better outcome, the world must act jointly and swiftly to revamp all aspects of our societies and economies, from education to social contracts and working conditions. Every country, from the United States to China, must participate, and every industry, from oil and gas to tech, must be transformed. In short, we need a “Great Reset” of capitalism.” [1]*

The vision of the WEF was a total do-over of society; financial, business, education and especially global thinking about climate change. This wasn’t an announcement that came from the President of the United States or any other country. It didn’t come from the United Nations or any other international body tasked with achieving international peace and security. Who and what was the World Economic Forum?

Membership in the WEF is limited to the world’s wealthiest and most powerful global Elites. They are multi-millionaires and multi-billionaires. They are corporate business leaders in the financial, insurance and banking industries. They are presidents and prime ministers of countries and global organizations. They are the heads of Elite, private academic institutions. They are not middle and lower-income, blue collar workers, yet they claim they want to “revamp” society for the betterment of that class of people.

*Have you ever looked at something that, when taken at face value, appears to be a reasonable and just idea, but still, it leaves you with a sense of unease?*

*An idea or a cause that makes you feel like there’s something more to the story, something just under the surface that just doesn’t feel right. Something that you just can’t seem to put your finger on?*

Every step the WEF has taken to implement this ‘Great Reset’ has removed a few more of the basic freedoms we have enjoyed and benefitted from for decades. They promote vaccine mandates and vaccine passports, digital identities and social credit systems. They promote “socially responsible” lending to businesses and individuals. They support the U.N. Sustainable Development Goals and carbon taxes. The WEF was a promoter of Diversity Equity and Inclusion policies and designed a universal set of ESG “metrics” to be imposed on global corporations and their customers. The WEF even promoted Modern Monetary Theory as a method of “shaping the New Economy and society.” Supporters of the Great Reset include Progressive politicians like former Vice President Al Gore, former Prime Minister of Canada, Justin Trudeau and former U.S. President Joe Biden, all of whom have made substantial policy changes to help the WEF in its efforts to achieve the Great Reset.

I think I’ve written enough on these topics by now to show just how detrimental they have been to individuals while significantly benefitting global Elites. Despite the hundreds of billions of dollars in pandemic stimulus payments to families and businesses in 2020 and 2021, income inequality continues to rise around the world. Neither the Sustainable Development Goals of the United Nations nor the Great Reset have been able to reverse income inequality. Instead, these policies have increased income inequality and caused people to fall further behind in achieving their goals and dreams.

*The Report on the Economic Well-Being of U.S. Households in 2024*, published by the Board of Governors of the Federal Reserve said that while most adults said their family's monthly income increased in 2024 compared with a year earlier, the share of adults who said their spending increased from the prior year was even greater, making their financial situation worse, not better. A 2024 report by the Pew Charitable Research Foundation titled, *The State of the American Middle Class*, states that “Americans are more apart than before financially.” The share of Americans living in lower-income households continues to increase, while the share of Americans in middle-income households continues to fall. As the world’s premier “organizer” of society, the World Economic Forum and the global Elites that follow and promote the Great Reset cannot allow anyone to stand in their way of achieving those ultimate goals. Our U.S. Constitution is a “threat” to those global Elites, this is why there has been so much talk about “expanding the Court” to dilute the conservative majority that uses our Constitution to base their decisions on. Our justice system is a “threat” to global Elites as well, this is why millions of dollars have been spent to elect progressive judges at state and local levels who support their agendas. A strong and well-informed middle-class has provided one of the best methods of checks and balances over history, removing politicians from office who don’t act in the best interests of the voter or the country and electing new ones to office. This is what threatens the interests of the global Elites the most and why so many of their policies and plans have resulted in the shrinking of the middle-class and “shaping” their education in progressive public universities.

On June 16, 2015, Donald Trump announced his candidacy for President of the United States. One of the biggest obstacles to achievement of the U.N. Sustainable Development Goals and the World Economic Forums Great Reset suddenly emerged...

*Our country is in serious trouble. We don't have victories anymore... When do we beat Mexico at the border? They're laughing at us, at our stupidity. And now they are beating us economically. They are not our friend, believe me. But they're killing us economically. The U.S. has become a dumping ground for everybody else's problems... When Mexico sends its people, they're not sending their best. They're not sending you... They're sending people that have lots of problems, and they're bringing those problems with [them, to] us.*

*A lot of people... can't get jobs. They can't get jobs, because there are no jobs, because China has our jobs and Mexico has our jobs... Our enemies are getting stronger and stronger by the way, and we as a country are getting weaker... you need somebody, because politicians are all talk, no action. Nothing's gonna get done... I've been on the circuit making speeches, and I hear my fellow Republicans... I like them. But I hear their speeches. And they don't talk jobs, and they don't talk China.*

*So I've watched the politicians. I've dealt with them all my life. If you can't make a good deal with a politician, then there's something wrong with you. You're certainly not very good. And that's what we have representing us. They will never make America great again. They don't even have a chance. They're controlled fully... they're controlled fully by the lobbyists, by the donors, and by the special interests, fully.*

*We need a leader that can bring back our jobs, can bring back our manufacturing, can bring back our military, can take care of our vets... We need -- we need somebody -- we need somebody that literally will take this country and make it great again. We can do that... So ladies and gentlemen I am officially running for president of the United States, and we are going to make our country great again.*

This, is what the global Elites feared, even back in 2016. Donald Trump was a businessman with a bachelor's degree in economics. He ran a real estate business, acquiring and building skyscrapers, hotels, casinos and golf courses. He hosted a reality TV show, filed business bankruptcies six times and rarely spoke about politics. He was a registered Republican whose political views developed over two decades and five party affiliation changes. He was an outsider running against career politicians for leader of the world's most powerful nation. In addition to the sixteen candidates in the Republican primary, Donald Trump faced opposition from former Republican presidents and cabinet members, Republican governors, Senators and House Representatives. He faced opposition by former Department of State and Department of Defense officials, National Security and Department of Justice officials that had been appointed to positions by Republican Presidents. <sup>[4]</sup>

Radio and television host Glenn Beck made a recent disclosure about a meeting he had with then President George W. Bush in 2008. Beck was called to the White House over criticisms he had made in a radio broadcast on how badly the Iraq war was going. Beck described the

conversation with the president... “I get there... and the first thing the president says to me is, “You know, a lot of people think they know how they could be the F-ing president. Well, they have no idea how to be the F-ing president....” After it was all over and he had it out of his system, we stood up at the end... He said, trust me, Glenn, whoever comes into this office, no matter which party they're in, they are going to sit behind this desk, and they're going to realize, because they're going to be advised by exactly the same people that have been advising me, that they really have no choice. This is what they have to do. And then he said, have a good day” [5]

That, is the perfect example of how politics work in Washington DC, “this is what they have to do”, with no deviation. Trump ran for president on a pledge to “drain the swamp”, to change the way things had always worked. And the establishment did not like that! Establishment Republicans did not want Donald Trump to become president, and when he did, they actively worked against his attempts to change the way government operated. Establishment Democrats fought Trumps efforts even harder. Global organizations like the United Nations and World Health Organization did not like Trumps nationalist policies to weaken their control over the United States. Environmental activists did not want Trump to change policies they had been able to put in place under the Obama administration. “Drain the swamp”, was the central topic of Trump’s campaign; and it resonated with voters who were fed up with partisan politics and the same results, election after election.

#### ➤ *The Real Election Interference*

There was a coordinated attempt to ensure Donald Trump would not become the next U.S. president as soon as he showed himself to be a legitimate contender by winning seven of eleven states on “Super Tuesday”, March 1, 2016, and then taking five of six states on March 15. In April 2016, the Hillary Clinton campaign and the Democratic National Committee hired the research firm Fusion GPS to continue “opposition research” on Donald Trump. Fusion GPS had hired former British MI-6 agent Christopher Steele to research any Russian connections to Trump and his campaign. Between June and December 2016, Steele provided 35 pages of memos full of accusations against Trump from anonymous sources, none of which could be substantiated. Out of this dossier came the allegations that Trump was “a Russian agent” and that Russian President Vladimir Putin personally ordered a Russian election interference operation to harm the Clinton campaign and ensure his victory in the election. Although U.S. intelligence agencies were skeptical of the claims, the Clinton campaign approved its release to mainstream media outlets that were supportive of her candidacy. The Russian collusion narrative had begun. [6]

#### ➤ *The Election Results and Continued Opposition*

The voters did not buy the Russia-Russia hoax, and they did not buy into Hillary Clinton’s campaign either. On November 8, 2016, American voters went to the polls. Although Clinton received 2.8 million more votes than Donald Trump, Trump won 30 of 50 states and 306 Electoral College votes to win the election. But even before he took the oath of office, Donald Trump was under siege.

It took 160 days for all of Trump's cabinet picks to be confirmed by the Senate, the longest time of any previous president. Even after cabinet members, appointees and staff were in place, the president fired dozens of administration insiders for leaking information to the press and working against his agenda. Dozens of other appointees resigned from positions as it became clear leaking, and insubordination was not going to be tolerated. Besides betrayals within the administration, Trump's policies led to Democrat state attorneys general filing 138 multistate lawsuits in attempts to overrule and stop his agenda. (For reference, the Obama administration was sued just 78 times over eight years, the Bush administration was sued 76 times over his eight years in office) Environmental groups filed hundreds of lawsuits against the Trump administration during his first term. The Center for Biological Diversity alone filed 266 lawsuits. California filed more than 100 environmental lawsuits against the Trump administration, at a cost of \$41 million to taxpayers over four years. <sup>[7]</sup> <sup>[8]</sup>

In September 2019, House Democrats opened an investigation into allegations that Trump requested the Ukrainian government investigate former Vice President Joe Biden and his son Hunter, in exchange for releasing \$400 million in U.S. foreign aid to that country. Trump denied he withheld military aid to pressure Ukraine to scrutinize Biden, a potential 2020 presidential rival. The scandal began when a CIA whistleblower filed a complaint that President Trump pressured Ukrainian President Volodymyr Zelenski to begin an investigation into Hunter Bidens activities and compensation on the board of Ukrainian energy company Burisma and connections with his father Joe Biden. Trump was doing his own "opposition research" on Joe Biden, just as Clinton did on him. Zelenski himself told reporters that "there was no blackmail" by Trump and he was unaware of any foreign aid being withheld. There was confirmation that the President did ask Zelenski to investigate Joe Biden stopping a corruption investigation into his son Hunter while he was Vice-President by threatening to withhold \$1 billion in foreign aid. Joe Biden himself confessed to doing this in a video interview during a Council on Foreign Relations discussion on January 23, 2018! But there was never any confirmation that Trump threatened to withhold aid to Ukraine in exchange for more information about this.

There have been multiple confirmed stories how Hunter Biden earned \$1 million per year for a position on the Board of Directors at Burisma Holdings, a Ukrainian energy company, despite having no previous experience in the industry. Hunter's only connection to the country was that vice-president Joe Biden was in charge of American policy in Ukraine. After Joe left the White House in 2016, Hunters compensation was cut to \$665,000 in 2017, and then \$498,000 in 2018. Hunters value to Burisma dropped dramatically as soon as his

father was no longer vice president. <sup>[9]</sup> Joe Biden claimed multiple times during the 2020 presidential campaign, that he knew nothing about his sons business dealings, either in the Ukraine or in China, and that "I have never spoken to my son about his overseas business dealings." This was proven to be a lie by sworn testimony from Hunters business partner Devon Archer to Congress in 2023, White House visitor logs showing Biden had meetings in the White House with at least 14 of Hunter Bidens business associates while vice president, and by emails found on Hunter Bidens laptop. <sup>[10]</sup>  
(More on the laptop later)

Former FBI Director Rober Mueller was appointed as Special Counsel in 2017 to oversee the investigation into Russian interference in the 2016 U.S. presidential election. His report was submitted to Attorney General William Barr on March 22, 2019, and a redacted version of the 448-page report was publicly released by the Department of Justice on April 18, 2019. Although the commission did not have access to all communications and some testimony was false or incomplete, the report concluded that while there was Russian interference in the 2016 election, there was no evidence to conclude that members of the Trump campaign conspired or coordinated with the Russian government in any election interference activities. While the results of the Mueller Report did prevent House Democrats from calling for President Trump to be impeached in charges of collusion with Russia, they held numerous hearings over a three-month period and voted to impeach Trump on charges of abuse of power and obstruction of Congress, by partisan vote in December 2019. The Senate acquitted Trump on both charges, also by partisan vote, in February 2020. <sup>[11]</sup>

### ➤ *2020 Presidential Election Controversy*

Even though he received 11.5 million more votes than in 2016, President Trump lost his campaign for re-election in November 2020 by 7 million votes against Joe Biden. In all, 21.5 million more ballots were cast in 2020 than in 2016, an astounding 15.76% increase in total votes cast. The increase in registered voters and voter turnout was significantly higher in 2020 than in previous elections as Biden received 15.4 million more votes than Hillary Clinton (who would have been the first woman president) did in 2016 and 11.7 million more votes than Barack Obama (the first black president) in 2008. Joe Biden won all six "battleground states" by a combined 313,343 votes. Just a 44,000-vote difference in Wisconsin, Georgia and Arizona separated Biden and Trump from a tie in the Electoral College. The number of ballots cast for Joe Biden in Wisconsin was 18% higher than Clinton received in 2016. In Georgia, it was 32% higher and in Arizona, it was 44% higher.

There have been various theories put forward as to why there was such a large increase in voting in 2020. These theories include rampant hatred of Donald Trump, the expansion of mail-in balloting due to the pandemic, ballot harvesting and outright voter fraud. A 2023 poll conducted by Rasmussen Reports and The Heartland Institute revealed that 21 percent of mail-in voters surveyed admitted they filled out a ballot for a friend or family member; 19 percent of mail-in voters admitted that a friend or family member filled out a ballot on their behalf; 17 percent of mail-in voters admitted they voted in a state where they were no longer

a permanent resident; and 17 percent of mail-in voters said they signed a ballot for a friend or family member with or without his or her permission. <sup>[12]</sup>

Nine months before the election, Forbes published an article titled *Harvesting Votes to Win in 2020*. The editor made the point that voting in person typically requires a person to show photo identification or sign the registration poll record when casting a ballot in person. But unlike when voting in person, voting by mail almost never requires an ID. The article went on to say mail in ballots lack the protections that voting in person provides. The article also noted, “ballot harvesters can get aggressive, they can cut corners, and they can guarantee votes for the politician or group that hired them by taking physical possession of ballots and voting in place of the legal voter.” <sup>[13]</sup> While the number of actual voter fraud cases uncovered in 2020 may not support the “stolen election” theory, the combination of pandemic changes to states voting laws does cast reasonable doubt on the “fairness” of the 2020 election.

➤ *Deep State Election Interference in the 2020 Election*

Discounting any voter fraud, Joe Biden received plenty of help from the media and government agencies throughout his 2020 election campaign, just as Hillary Clinton did in 2016. Nothing proves the truth of this statement better than the Hunter Biden laptop saga.

In April 2019, Hunter Biden dropped off three damaged laptop computers at *The Mac Shop*, an Apple computer repair shop in Wilmington, Delaware. Biden asked owner, John Paul Isaac, to repair the laptops or if he can't, to recover data from their hard drives. Biden signed the work order but never returned to reclaim the laptops after repeated calls from Isaac. Isaac examined contents of the hard drive of one of the laptops and discovered evidence of suspicious monetary transactions, as well as a large number of pornographic images and emails to and from Hunter Bidens business associates and his father, Joe Biden. In October 2019, Isaac called a local FBI office to report what he had found on the laptop. In December 2019, the FBI seizes the laptop by authority of a Grand Jury subpoena. Agents that inspect the laptop determine that it did belong to Hunter Biden, and the contents of the hard drive did not seem to have been tampered with or manipulated. <sup>[14]</sup>

Isaac had made a copy of the contents of the hard drive before turning it over to the FBI, and after reading about a Senate Republican-led committee investigation into foreign influence-peddling by members of the Biden family, Isaac alerted Congress members to the existence of files on the laptop in September 2019. A copy of the hard drive was also given to Donald Trump's lawyer Rudy Giuliani, who shared files with the New York Post.

On October 14, 2020, three weeks before the presidential election, the New York Post published its first article titled, *Smoking-gun email reveals how Hunter Biden introduced Ukrainian businessman to VP dad*, based on emails recovered from Hunter Bidens laptop. This is important, because Joe Biden had claimed multiple times that he had no knowledge of his sons foreign business dealings and the two never discussed Hunter business. <sup>[15]</sup> Immediately after the New York Post story aired, the Biden campaign “persuaded” 51 former intelligence officials to sign onto a letter to discredit the Post story as Russian

propaganda and the laptop to be “a Russian plant”, despite the FBI having determined the authenticity of the laptop ten months earlier. Top FBI personnel labeled the story “disinformation” and a “Russian hoax”. CIA director Mike Morell later admitted he organized the infamous letter after discussions with members of the Biden campaign, including key advisor Antony Blinken. Top CIA officials recognized that the statement was political but approved and expedited its release in a move that deviated from standard Prepublication Classification Review Board protocols. [16][17] Mainstream media repeated the claims nightly. Social media suppressed the laptop story.

Joe Biden received 81.3 million votes in 2020. A Media Resource Center poll taken after the election showed that 17% of Biden voters would have avoided picking Biden if they knew of stories the media suppressed. That 17% equals 13.8 million votes. Biden beat Donald Trump by 7.06 million votes. The bottom line is, there was election interference in the 2020 election, perpetrated by mainstream media and “the Deep State”, that led to Joe Biden being elected President of the United States. This, led to claims by Donald Trump and his lawyers that the election was stolen and the debacle that followed on January 6, 2021. [18]

➤ *“Insurrection” at the Capitol – the Second Trump Impeachment*

*“On January 6, 2021, the United States Capitol in Washington, D.C., was attacked by a mob of supporters of President Donald Trump in an attempted self-coup, two months after his defeat in the 2020 presidential election. They sought to keep him in power by preventing a joint session of Congress from counting the Electoral College votes to formalize the victory of the president-elect Joe Biden.”*

Wikipedia has a “left-wing bias”. This assertion is backed up by Wikipedia co-founder Larry Sanger, who called Wikipedia “propaganda” for left leaning “establishment” views, in July 2021. Sanger also noted that right-leaning sources and views are systematically blocked by editors. *Influence Watch* notes “Wikipedia editors have engaged in editing and counter-editing on profiles dealing with contentious political and cultural issues”, mostly against the right. The Wikipedia article seeks to place the blame solely on Donald Trump for the events of January 6, and gives a biased opinion on the second impeachment of President Trump. President elect Joe Biden called the rioters “domestic terrorists”. Democrats called Jan. 6 “The worst attack on democracy since the Civil War”.

Mainstream media repeated the claims nightly. Social media did not block this story!

There are a number of video documentaries on YouTube that tell the story about January 6 from the opposite side; *The January 6 Stories the Media Doesn't Want You to Hear*, produced by Prager U, *What Really Happened on January 6<sup>th</sup>*, a podcast interview by Dr. Jordan B. Peterson, *Here's What Really Happened on January 6<sup>th</sup>*, produced by Tucker Carlson, and *What He Saw on Jan. 6 - Former Capitol Police Officer Speaks Out About Jan. 6 Protest*. I have seen all these videos, and I've read *Courage Under Fire: Under Siege and Outnumbered 58 to 1 on January 6*, written by former Capitol Police Chief Steven A. Sund.

These accounts from people who were at the Capitol on January 6, 2021, tell a different story about the events and why they happened that day. Law enforcement was aware there was going to be a significant protest the morning Congress was to certify the results of the 2020 election and that President Trump planned to speak to his supporters and encourage them not to accept the results. Top level administrators did not give all the intelligence information to the Capitol Police, who were responsible for security at the Capitol building. This resulted in an insufficient number of officers on duty that day to handle crowd control and security. Once Chief Sund realized how outnumbered his men were, he repeatedly requested permission from the House and Senate Sergeant-at-Arms to call for support from the D.C. National Guard. Sund stated his requests were denied due to concerns about “optics” of deploying the National Guard. In all, Sund’s requests of the Sergeant-at-Arms were refused six times. Sund also asked the Pentagon to provide backup for his men several times during the rioting. Senior Army officials delayed for more than three hours sending the National Guard to the Capitol.

Chief Sund had asked his superiors for more help even *before* the rally began. His request was refused. President Trump himself requested 10,000 National Guard troops to provide security at the Capitol on January 3. This request was never acted on.

Note: By Inauguration Day 2021, Democrats stationed more than 26,000 armed guardsmen in Washington, erected seven foot high riot fencing topped with razor wire, and closed the National Mall and inaugural viewing stands, claiming Trump supporters would attempt to interrupt the ceremony. Apparently, they had no problems about “optics” this time...

A suspicious person would begin to think the denials and delays were intentional, that those in power wanted a riot to happen. This would destroy any legacy left by Donald Trump and almost assure he would never be elected president in the future.

Adding to the suspicions, were allegations about FBI operatives helping to incite the crowd, armed police officers not only *not* telling people to leave the Capitol, but in some instances escorting them through hallways. I won’t go into any detail about the arrests and prosecutions of those who entered the Capitol grounds or building that followed, other than to say the Biden Department of Justice and the FBI made sure they were severely punished. The message was clear, do not oppose us or we will arrest you, seize your personal belongings, and charge you with multiple felonies that could put you in jail for as many as 80 years unless you sign a plea agreement. And in cases where people refused to admit what the DOJ wanted them to, they were held in prison in solitary confinement until their trials, lost their jobs, lost their finances. Their lives were destroyed, and they had to rebuild them.

In the words of Jan. 6 defendant John Strand, “... going to trial means you go before a DC judge and a DC jury because they wouldn't release jurisdiction of any of these cases. This is a district that voted 93% against Donald Trump. I say against Donald Trump because nobody voted *for* Joe Biden. People only voted *against* Donald Trump. They hate Donald Trump. They hate his supporters. They hate guys like us. Nobody stood a chance going to trial in DC, which is why they've gotten a 100% conviction rate for January 6 cases...”

“I pled not guilty because I am innocent. I knew the jury would convict me in advance anyway because it's DC. I said that publicly in advance. I was proven right. I continued to castigate a fraudulent system and a dishonest and very partisan judicial process, a weaponized government... when I finally got to sentencing, the judge was furious. He said it from the bench that I'm sending a message that this can never happen again. People cannot basically do what I had done, which was to speak publicly and criticize the government. They made an example out of you. Yeah. That's the textbook definition of fascism. The government said from the bench, he said, "I'm going to send a message. If you criticize the Washington DC court system, you go to prison for years is what happens."

Strand spend four months in solitary confinement waiting for trial, then was sentenced to two years and eight months in prison after a Washington, D.C., jury found him guilty of a felony charge of obstruction of an official proceeding and four misdemeanor violations stemming from the Jan. 6, 2021, attack at the Capitol. The Deep State continued to persecute Donald Trump and his supporters years after he left office. In June 2024, the Supreme Court ruled one of the charges brought against more than 330 Jan. 6 “rioters” to be inappropriate, leading the government to drop charges against them. And even though he was scheduled to leave office one week later, House Democrats brought impeachment charges against Donald Trump for a second time, for “incitement of insurrection”.

I personally believe that while Donald Trump was not responsible for inciting any insurrection, he let his anger and frustration at being defeated by Joe Biden cause him to exercise terrible judgement and make inappropriate statements, especially telling Vice-President Mike Pence he must stop the certification. I think he exercised bad judgement calling for his supporters to protest and then going to the Ellipse to address his supporters the morning of January 6. These acts certainly tarnished everything that he accomplished in his first term, and it gave the left even more reason to hate him and fight against a second Trump presidency.

➤ *The Truth Begins to Emerge*

\* On November 21, 2022, two years *after* the election, CBS published an article titled, *Copy of Hunter Biden laptop data appears genuine, independent experts find*. “The laptop data we had analyzed showed no evidence it was faked or tampered with” CBS reporter Catherine Herridge reported. The media finally acknowledged what the FBI had determined in 2019, that the laptop was owned by Hunter Biden and had not been tampered with. <sup>[19]</sup>

\* In September 2023, over 700 pages of whistleblower documents were released by the House Ways and Means Committee. The documents showed a series of meetings occurred between senior White House staff, Hunter Biden and his business associate Devon Archer, in the same year then-Vice President Biden made three visits to Ukraine. Committee Chairman Jason Smith stated, “House Republicans are determined to get to the bottom of the Biden family’s influence peddling scheme, and the American people have a right to know if then-Vice President Biden used his official government position to help his family’s overseas business operations... Thanks to the IRS whistleblowers we know President Biden

lied when he said he had no knowledge and was not involved in his son's business dealings. It now appears he in fact benefited. We will continue to follow the facts in this investigation and present the truth to the American people.” [20]

\* A September 27 press release posted on the House Ways and Means webpage stated, [21] *The scheme generated millions of dollars from foreign countries for members of the Biden family, channeled through a vast array of corporate entities and shell companies. The evidence also documents a campaign by the Justice Department to protect the Biden family from investigation, even as Hunter Biden attempted to evade paying taxes on income that came from foreign countries, including China, Ukraine, and others. That Biden protection effort was strongest whenever investigative steps might have led to or implicated actions taken by Joe Biden. During the investigation into his son, officials instructed investigators seeking a search warrant to erase any mention of a “Political Figure 1,” who documents reveal to be Joe Biden.*

\* On January 17, 2024, Federal prosecutors with the Biden Department of Justice confirmed that the laptop Hunter Biden dropped off at a computer store was in fact real, adding that the contents on the laptop matched what had previously been obtained through a search warrant on the president's son's Apple iCloud. This data was provided to the FBI by Apple in September 2021, but the FBI did not publicly acknowledge the authenticity of the laptop for another twenty-eight months! The Deep State continued to protect the Bidens for almost three years after Joe Biden was elected president! [22]

Everything President Trump had claimed to be true in October 2019, was finally proven to be true. The laptop was Hunter Bidens. The laptop contained emails showing that Joe Biden not only knew about his sons dealings in Ukraine and China, but he was responsible for Hunter being hired to the board of Burisma Holdings and Chinese energy firm CEFC China Energy. Emails on the laptop also showed that Burisma paid Hunter a salary of \$83,000 per month, and Chinese energy firm CEFC China Energy paid entities controlled by Hunter Biden or his uncle James Biden \$4.8 million over the course of 14 months beginning in 2017.

Another email on Hunter's laptop confirmed that CECF was expected to pay 20% of compensation to Hunter Biden, 10% to (Joe Bidens brother) Jim Biden and 10% would be held by Hunter for “the big guy”, meaning Joe Biden himself. IRS investigators in the Hunter Biden tax fraud case were blocked by a senior prosecutor from pursuing any leads that involved President Joe Biden. "I would say that they limited certain investigative leads that could have potentially provided information on the president of the United States," IRS agent Gary Shapley said. [23]

Joe Biden repeatedly lied to the American public about his part in the Ukraine/China business dealings with Hunter Biden. High level officials in the FBI, CIA and other U.S. intelligence agencies lied to the American public about the authenticity of Hunter Bidens laptop and helped block the story from being published. Mainstream media outlets pushed those lies to the American people during the presidential election cycle. Allegations of influence peddling and corruption were blocked by the Justice Department and FBI, and nothing came of efforts by the Republican led committee to hold the Biden's accountable.

Note: FBI Director Christopher Wray refused to turn over an investigative memo alleging a bribery scheme involving Vice-President Joe Biden and a foreign national, to the House Oversight Committee in 2023. <sup>[24]</sup>

➤ *The Second Trump Presidency – Continued Persecution*

On November 15, 2022, Donald Trump announced his campaign for president for a third time. Seventeen other candidates also announced their intention to seek the Republican nomination for president. Ten candidates withdrew before the first primary on January 15, 2023, which Trump won by a landslide. Six of his seven challengers dropped out of the race after the Iowa Caucuses and his final challenger dropped out of the race on March 6. Donald Trump became the Republican nominee for the third consecutive election on July 15, 2024.

Once again, as Trump became a threat for the Democrat candidate during the primaries, the Deep State was at work trying to deny him victory. By March 4<sup>th</sup>, when the Supreme Court unanimously declared them to be unconstitutional, 35 Democrat controlled or ‘swing’ states, had filed challenges to keep Donald Trump off the November ballot, citing his alleged involvement in the January 6 “insurrection” as grounds for disqualification. This, was the entire reason why Democrats brought the second impeachment charges against him; they wanted to prevent Trump from running against Joe Biden in 2024! <sup>[25]</sup>

\* In August 2020, New York Attorney General Letitia James, who’s 2018 campaign pledge was to sue former President Donald Trump and be a real “pain in the ass” to him, began an investigation into his business dealings in New York City. In September 2022, James filed a Civil lawsuit against Trump, three of his children, business associates and ten Trump business entities for engaging in “financial fraud”. The charge consisted of claims that the Trump organization “grossly inflated” property values in order to receive better lending terms with banks he had borrowed from publicly disparaging the court staff and himself as judge. In September 2023, Manhattan-based state Supreme Court judge Arthur Engoron determined that Trump and his company had committed fraud for years, and the trial could proceed. Engoron terminated the organizations business licenses and dissolved their LLCs. In February 2024, Engoron found the defendants guilty and ordered them to pay a \$454 million judgement. The judge set bail for Trump and his sons at \$4 million each and \$1 million for one of Trump’s business partner’s. <sup>[26]</sup>

Note: No local, state or federal funds were involved. Loans were fully repaid to lenders, with interest. Lenders were apparently satisfied with the terms in question, as they continued to loan money to Trump business entities. No one was harmed. The bail levels were later lowered by a New York Appellate Court.

Note: On August 21, 2025, a New York Appeals Court voided the judgement, which had grown to more than \$500 million with interest, as being “excessive”. Two of the four judges said the trial court was wrong to decide Trump committed fraud and the case should be retried. A fifth judge said New York Attorney General Letitia James should not have brought the case in the first place. Attorney General James vowed to appeal the case to the state’s highest court in an attempt to reinstate the penalty. <sup>[27]</sup>

\* On August 8, 2022, the FBI executed a search warrant authorized by Attorney General Merrick Garland at Donald Trump’s Mar-a-Lago residence in Palm Beach, Florida. [28] The referral came at the request of National Archives and Records Administration head Debra Steidel Wall for violations of the Espionage Act regarding unauthorized retention of national defense information, destroying or concealing records “with the intent to impede, obstruct, or influence” federal government activity and illegal removal or destruction of federal government records. According to documents on file with the Committee, in February 2022, NARA requested a meeting with Committee on Oversight and Reform Democrats on this issue and failed to include Committee Republicans. This raised concerns that NARA had been treating the Trump Administration’s handling of presidential records as a partisan political issue. [29] The FBI labeled and seized multiple boxes holding some 13,000 documents, 102 of which were classified. The seizure resulted in the Biden Department of Justice filing multiple federal charges, which resulted in a trial date being set for May 20, 2024, five and a half months before the presidential election. After being indicted by a Grand Jury on June 8, U.S. District Court Judge Aileen Cannon dismissed the case, ruling that the Biden D.O.J. appointment of Special Consul Jack Smith violated the Constitution.

Note: Joe Biden also faced charges in late 2022 over the same classified documents situation that his D.O.J. brought federal charges against Donald Trump for. Instead of being secured in a locked storage room in his home, boxes of documents, including top secret documents, were photographed in Bidens garage, visible from his driveway through an open overhead door. In February 2024, at the same time it was pursuing criminal charges against Donald Trump, the Justice Department decided *not* to pursue criminal charges against Biden, despite finding evidence that he willfully retained classified materials.

“Our investigation uncovered evidence that President Biden willfully retained and disclosed classified materials after his vice presidency when he was a private citizen... We conclude that no criminal charges are warranted in this matter...” [30]

\* In November 2022, Attorney General Merrick Garland appointed Jack Smith to lead a special counsel investigation into charges that Donald Trump had attempted to overturn the 2020 election. A Grand Jury in Washington DC, in which Trump had received just 4% of the vote in the 2016 presidential election and 5% of the vote in 2020, indicted the Republican candidate for president on multiple conspiracy charges, the most serious of which could have resulted in a 20 year prison term. The case was dismissed by the DOJ after Trump won the November 2024 election.

\* On March 30, 2023, Manhattan District Attorney Alvin Bragg presented a criminal indictment to a Grand Jury against Donald Trump, who was now the presumptive Republican nominee for president in 2024. Trump was charged with 34 felony counts of falsifying business records in order to conceal payments to porn actress Stormy Daniels to cover up a consensual sexual encounter that had occurred seventeen years before. In order to make the case more sensational, D.A. Bragg charged Trump on multiple counts for each of the twelve payments made and categorized them as “attempts to violate state and federal election laws”. Bragg made the claim that his case was about “election interference” by “conspiring to corrupt a presidential election” because Trump was concealing damaging

information ahead of the vote. Federal Prosecutors had already investigated this case in 2018 and chose not to bring charges against Trump under federal campaign finance law for the same scheme. Bragg was accused of “falsifying charges” and having no jurisdiction to enforce federal election laws. <sup>[31]</sup>

A Grand Jury in Manhattan, a county in which Trum had received just 9% of the vote in the 2016 presidential election and 12% of the vote in 2020, indicted the Republican candidate on all charges. The case would remain in the news all during the campaign cycle and resulted in another Manhattan jury finding Trump guilty on all counts in May 2024. Democrats repeatedly referred to Trump as “a convicted felon” during the campaign and the media cooperated by repeating the story and claims often.

\* On August 14, 2023, a Fulton County Grand Jury, a county in which he had received just 27% of the vote in the 2016 presidential election and 26% of the vote in 2020, indicted Republican presidential candidate Donald Trump and 18 other defendants on 41 charges over alleged attempts to overturn 2020 election results in Georgia. The case was plagued with controversy as Fulton County District Attorney Fani Willis acknowledged having a “personal relationship” with lead prosecutor Nathan Wade after previously denying the affair. Wade, who was paid over half a million dollars more than other special prosecutors on the case, resigned as special prosecutor in March 2024. Willis was disqualified from prosecuting the case by the Georgia Court of Appeals in December 2024, and the case was dismissed. Her appeal to continue prosecuting Trump was denied by the Georgia Supreme Court on September 16, 2025. <sup>[32]</sup>

Five criminal or civil cases were brought against Donald Trump during the four years after he left the White House and was later voted back into it. Each trial, if he was found guilty, would have resulted in a prison sentence or massive financial penalty. Similar to the Jan. 6 cases mentioned before, these lawsuits were a warning to Trump and/or an attempt to prevent him from running again in 2024. <sup>[33]</sup> The voters did not buy into the Democrat led criminal and civil charges, and they did not buy into Kamala Harris’ campaign either.

On November 5, 2024, Donald Trump was elected as the 47<sup>th</sup> President of the United States. This time, Trump won the popular vote by 2.284 million ballots, the Electoral College vote 312 to 226, and won all seven “battleground states”, flipping five of them from results in the 2020 election. Fifty-six percent of voters showed their opposition to a continuation of Biden-Harris administration policies, and eighty-eight percent of those voters cast their ballot for Donald Trump. His 77.285 million votes was the largest total ever for a Republican candidate. Suspiciously, 3.1 million fewer votes were cast in 2024 than in 2020 and Kamala Harris received 6.2 million fewer votes than Joe Biden received in 2020. These results once again led to questions about why there were so many ballots cast in 2020 for the Democrat candidate and overall, and where did the missing voters go in 2024?

### ➤ *The Aftermath*

Hillary Clinton was sure that she was going to be the 45<sup>th</sup> president of the United States and the first woman president. At the evening of November 8, 2016 progressed, key states were

called for Donald Trump; Ohio at 10:39 pm, Florida at 10:53 pm and North Carolina at 11:56 pm. I remember watching the election results on television and the CNN commentator was frantic... “*she’s got to do something*” the woman said. But nothing could be done...

At 1:35 am Wednesday morning, Pennsylvania was called for Trump and the outcome was sure. John Podesta, Clinton’s campaign manager refused to concede, even though Trump was leading in Wisconsin, Michigan and Arizona. At 2:30 am, Wisconsin was called for Trump, and it became official. Donald Trump was the 45<sup>th</sup> President of the United States.

Clinton refused to take any of the blame for alienation of voters and her loss to Trump. Several times in national TV interviews over the months and years that followed, she blamed FBI Director James Comey for his announcing eleven days before the election, that the FBI was reopening its investigation into her private email server during her tenure as Secretary of State. She blamed Russian President Vladimir Putin for election interference through cyber-attacks and spreading disinformation. She blamed Wikileaks for releasing hacked emails from her campaign. She blamed the media for how it covered her campaign and the FBI investigation. She blamed men in general stating that sexism and misogyny played a significant role in her defeat. [34]

Hillary Clinton had the support of the Deep State, and she lost the election anyway. How much support was never proven until just recently. In May 2023, Special Counsel John Durham released the final report of his four-year investigation into 2016 Russia election interference and the FBI’s “Crossfire Hurricane” investigation. Durham concluded that there was insufficient evidence to tie Donald Trump to Russian collusion and that the FBI investigation should never have happened. [35] The report stated that the FBI used “raw, unanalyzed, and uncorroborated intelligence,” to launch the investigation into Trump and Russia but used a different standard when weighing concerns about alleged election interference regarding her own campaign. This, in reference to the opposition research her campaign funded which produced the unsubstantiated and discredited “Steele Dossier.”

But an additional section of the Durham report, the now declassified *Classified Appendix*, was never released to the public until July 31, 2025. This redacted Appendix, “provides further factual background about the possible Clinton campaign plan” to discredit Donald Trump before the 2016 election. [36] [37]

Ref: Classified Appendix; 1. Section IV.C.1 – Investigative referral of possible Clinton campaign plan

The Appendix shows that Russian intelligence services hacked numerous U.S. public and private entities, including government agencies. Among the entities hacked, was the Open Society Foundation (OSF) of the notorious George Soros, and the Democratic National Committee (DNC). The Appendix reveals multiple emails between OSF Directors Leonard Benardo and Jefferey Goldstein, and DNC Chair Debbie Wasserman-Schultz. These emails and other “sensitive intelligence”, were provided to the FBI by unnamed officers in U.S. national intelligence agencies.

In a January 12, 2016 email, Wasserman-Schultz discusses her concerns about the FBI investigation into Hillary Clinton, with Goldstein. According to Wasserman-Schultz, “FBI, so far does not have “pervasive evidence” against Clinton because of the “timely deletion of relevant data from email servers.” Wasserman-Schultz reveals to Goldstein that the DNC and/or the Department of State has deleted documents pertaining to the Clinton Foundation. Because of this, the FBI has no evidence to prove corruption charges against the Clintons. Wasserman-Schultz goes on to implicate President Barack Obama in the coverup; “Obama has no intention to darken the final part of his presidency and “legacy” by the scandal surrounding the main contender from the Democrat Party (DP).”

Fact: Wasserman-Schultz stated that President Obama pressured the FBI *not* to investigate the Clinton Foundation, so “his legacy” will not be tarnished by his association with Clinton as Secretary of State and large foreign donations to her foundation.

In a March 5<sup>th</sup> email with OSF Director Bernardo, Wasserman-Schultz states, “In relation to the consensus reached among the Democratic Party leadership regarding the candidacy of Hillary Clinton, Barack Obama sanctioned the use of all administrative levers to remove possible negative effects from the FBI investigation of cases related to the Clinton Foundation and the email correspondence in the State Department.”

Clintons political director Amanda Renteria regularly receives updates on the FBI’s investigation from AG Loretta Lynch. Durhams report goes on to note that “A two-prong DP opposition is focused on discrediting Trump through debates and propaganda activities based on his weak points... Among other things, the Clinton staff, with support from special services, is preparing scandalous revelations of business relations between Trump and the ‘Russian Mafia.’

Fact: President Obama actively subverted any negative effects from the FBI investigation, and the Attorney General gave the Clinton campaign updates so they could be prepared to deflect any allegations.

Fact: The Clinton campaign had help from her supporters in “special services”, which refers to the FBI, CIA, DOJ, etc. (Remember the “51 former senior intelligence officials” who signed that letter stating the Hunter Biden laptop had, “all the earmarks of a Russian intelligence operation’ just weeks before the 2020 election?)

On March 31, 2016, FBI Deputy Director Andrew McCabe, FBI Chief of Staff James Rybicki, FBI Deputy General Counsel Trisha Anderson, FBI Assistant Director for the Cyber Division James Trainor met with other senior “career officials” in the FBI and informed them that the FBI’s assessment of the information the Clinton campaign was preparing to use against Trump was “likely not credible.” Their assessment said the report had “multiple levels of hearsay, that sources “engaged in exaggeration”, the person who drafted reports (Christopher Steele) “may have engaged in editorialization or exaggeration, and finally, the reports “may be unreliable due to translation errors” from Russian sources.

Fact: The FBI came to the conclusion that the “scandalous revelations” the Clinton campaign were preparing to release to the public about Trump and Russia collusion were not credible for a number of reasons.

Fact: FBI Deputy General Counsel Trisha Anderson told investigators that Attorney General Lynch was pressuring FBI Director James Comey not to continue the investigation into the Clinton Foundation or her email correspondence as Secretary of State, and this gave Comey additional reasons to doubt the Steele dossier and the Russia collusion claims.

Fact: Hillary Clinton personally approved the plan of her foreign policy advisor, Julianne Smith, to “smear Donald Trump by magnifying the scandal” that Russian special services attempted to hurt Clinton and benefit Trump. The same documents which Hillary Clinton knew herself were unproven and the FBI concluded were not credible. Smith’s plan envisioned raising the Russia collusion scandal to such a high level, that voters would be diverted from the FBI investigation into her email correspondence.

Note: The email correspondence refers to Clinton’s unauthorized use of a private, unsecured email server during her tenure as Secretary of State. The use of a private email server instead of an official State Department email account maintained on government servers, violated federal law. The FBI investigation determined that Clinton had sent 100 emails that would have been classified at the time they were sent, with 65 of those emails classified as Secret and 22 Top Secret. While Clinton claimed that she violated no laws because former secretaries of state also used private email accounts, she was the only one who used an unsecured, private *server*. FBI Director Comey decided *not* file charges against Clinton in July 2016. [38]

The Appendix also notes, “due to lack of direct evidence”, Julianne Smith decided to send the fake Russia collusion information to media outlets using “FBI-affiliated” cybersecurity companies. Smith felt this would give the “scandalous revelations” the impression of being factual, coming from companies linked to the FBI.

Fact: The Clinton Campaign deliberately sent discredited information to media outlets for publication, with the help of supporters inside the FBI. Although Trump declared the news articles were “a Hoax” and this was proven by both the 2019 Mueller Report and the 2023 Durham Report, Liberal media outlets claim Putin and Trump colluded to “fix” the 2016 election to this day.

### ➤ *Conclusions*

The *Classified Appendix* is 29-pages long so I could go on, and on, but the data obtained from the Hunter Biden laptop and the release of the Appendix is clear. It proves;

1. FBI insiders engaged in election interference in both the 2016 and 2020 elections.
2. FBI insiders withheld information from the American public that would have shown Joe Biden had engaged in a “pay-for-play” scheme, enriching himself and his family.

3. Joe Biden used his position as Vice-President of the United States, to enrich his family and himself, through business dealings with foreign governments and businesses.
4. Joe Biden lied multiple times to Congress and the American public, about his knowledge of and participation in his sons business dealings in the Ukraine and China.
5. Hillary Clinton, or her aides, deleted emails from her personal private server, to hinder the FBI investigation. The FBI also determined that aides physically destroyed “electronic devices” using hammers.
6. The Obama administration attempted to obstruct the FBI investigation into Hillary Clinton, the same charge that Donald Trump Democrats used during his first impeachment. The Attorney General of the United States personally attempted to stop the FBI investigation and President Obama himself sanctioned the obstruction efforts.
7. The Clinton campaign pursued a plan to tie Donald Trump to the Russian election interference operation, using the unproven Steele Dossier to “smear Donald Trump.” Hillary Clinton herself approved the plan.
8. Although top FBI officials determined the dossier was not credible, Clinton supporters inside the FBI helped her campaign by feeding the documents to news media for publication.

The Deep State, global Elites and their supporters, will stop at nothing to destroy anyone who stands in their way of achieving their goals. Donald Trump took up on day one, January 2025, right where he left off in 2021, with a flurry of executive orders on climate change, illegal immigration, free speech and censorship, DEI programs, and gender ideology. He once again stated that foreign policy would revolve around America First and withdrew from the Paris Climate Agreement and World Health Organization.

Global Elites met for the 2025 World Economic Forum meeting in Davos Switzerland just days after Donald Trump took office. Sixty heads of state met to analyze progress on *The Great Reset* and plan how to further their agenda. They emphasized use of their “Global Collaboration Village”, a cloud based virtual meeting platform defined as “the future of public-private cooperation” by the WEF. This digital technology is envisioned by global Elites as a way to “enhance global cooperation.” They were also quick to express criticism of Trump’s America First agenda and the U.S. pulling out of global organizations as part of this agenda. <sup>[39]</sup>

“The 2015 [Paris climate] accord remains the best hope for all humanity” stated European Commission President Ursula von der Leyen, as she pledged that the EU will keep working to stop global warming. “We are witnessing a backsliding in democracy everywhere in the world, even in the most advanced democracy. It is a movement into the bad — in the wrong direction” stated Alain Berset, head of The Council of Europe, billed as the continents leading human rights organization.

Note: Berset criticized Trumps gender ideology policies saying, “There has been, not only a failure to advance, but a regression in gender equality” at the annual conference of the Gender Equality Commission on September 2025. Berset intermixes gender with sex,

claiming that people like Donald Trump are the reason that “half the population is being denied equal access to the public life.”

*“We are here to develop the great narrative, a story for the future... In order to shape the future, you have first to imagine the future, you have to design the future, and then you have to execute it.”*

Klaus Schwab, Great Narrative Meeting, 2021

### ➤ *Final Thoughts*

In order to “execute” their version of the future, global Elites need the full cooperation of the United States, which traditionally has been an independent nation. The Trump administration has no intention cooperating with that global vision. The 80+ million people who voted against the continuation of Biden-Harris administration policies have no intention cooperating with that global vision. Donald Trump survived betrayal by his own administration picks during his first presidency, persecution by the Deep State during two elections, collaboration of mainstream media, social media and tech companies against him, five criminal or civil cases brought by hostile law enforcement leaders, hundreds of lawsuits by states Attorney Generals and environmental groups, two impeachment attempts and two assassination attempts. And yet here he is, once again, president of the United States and putting up roadblocks to global Elites agendas, agendas that have done nothing to improve lives but instead further increase income inequality and lower the standards of living for millions. There is not a doubt in my mind that these persecutions, these attempts to prevent “execution” of the Great Reset will continue and they will be more and more violent.

### ***Why Progressives Increasingly Support Violence***

*A new survey finds more than half of left-wing respondents believe assassinating Donald Trump could be justified.*

*A new report from our group, the Network Contagion Research Institute, provides answers. Our research, based on nationally representative surveys and analyses of online activity, demonstrates the existence of online subcultures that support the murder of public figures like Trump and Musk. This “assassination culture,” incubated on social media, has migrated from the margins of public life into the mainstream.*

*We found that nearly one-third of Americans surveyed—and around half of those identifying as left-of-center—believe that the murder of certain public figures is at least somewhat justified. The figures are startling: 38 percent of respondents, and 55 percent of those left of center, said assassinating President Trump would be at least somewhat justified; 31 percent of respondents, and 48 percent of those left of center, said the same about Musk. Forty percent of respondents, and 58 percent of those left of center, deem it at least somewhat acceptable to “destroy a Tesla dealership” in protest.*

Note: On September 10, 2025, five months after that article was published, Charlie Kirk was assassinated while addressing an audience on the campus of Utah Valley University in Orem, Utah, by 22-year old Tyler Robinson, who was in a romantic relationship with a transgender woman and told his parents, "there is too much evil and the guy spreads too much hate" when asked why he killed Kirk.
