Squad 2.0: Meet America's next wave of radical Democrats shaping the party's future

Galvanized by President Donald Trump's sweeping second-term agenda, a new generation of progressive Democrats is working to redefine the party's future.

The original "Squad," a group of young, left-wing lawmakers, including Rep. Alexandria Ocasio-Cortez, D-N.Y., was elected to the U.S. House of Representatives in 2018 as a referendum on Trump's first term.

Now, with Trump back in the Oval Office and Republicans controlling both the House and Senate, a new wave of progressive candidates is emerging across the country.

The “Squad” is a far left-wing progressive faction of the Democratic Caucus, initially elected by voters to oppose the Trump administration; Alexandria Ocasio-Cortez (NY), Ilhan Omar (MN). Ayanna Pressley (MA) and Rashida Tlaib (MI) in 2018, Jamaal Bowman (NY) and Cori Bush (MO) in 2020, Greg Casar (TX), Summer Lee (PA) and Delia Ramirez (IL) in 2022. They’ve supported Medicare for All, the Green New Deal, tuition-free college and college loan forgiveness, criminal justice reform, racial and economic justice and immigration “reform”, meaning citizenship and voting rights for illegal immigrants. Bowman and Bush were defeated in the November 2024 primary elections, but for every Squad member sent packing by voters in 2024, there are many others waiting to replace them.

1. Jasmine Crockett (age 44) was elected to represent Texas’ 30th Congressional District (a primarily black- and Hispanic-majority area) in a 2023 special election and won reelection in November 2024. Crockett holds many of the same opinions on policy as the remaining Squad members and frequently engages in nasty and violent language. Crockett mocked Texas Governor Gregg Abbot, a paraplegic, calling him “Governor hot wheels”, demanding that Elon Musk must be “taken down”, said Senator Ted Cruz “has to be knocked over the head, like hard” and called President Trump a “piece of shit.” Crockett has also downplayed illegal immigrant crime claiming that White supremacists are a bigger threat, while referring to ICE Enforcement and Removal Operations as “slave patrols.” In light of the losses Democrats sustained in the November 2024 elections, Crockett spoke about Democratic donors, who are looking for a viable presidential candidate to run in 2028: “I had a donor on the phones with me, telling me that all the donors are lining up behind that (one specific) candidate,” she said. “So I can tell, and I tell you, it’s not a Black person nor a woman... let’s go find the safest *white boy* we can find.”

Jasmine Crockett, foul mouth bully, supporter of political violence and blatant racist, called by some as the future of the Democrat party. Think about *that* for a minute...

2. Aftyn Behn (age 36), member of the Tennessee legislature is campaigning to represent Tennessee's 7th Congressional District, one of the most Republican districts in Tennessee. Aftyn describes herself as a "pissed off social worker," running for Congress in response to the One Big Beautiful Bill Act, which she describes as "a giveaway to the wealthy that codified the largest transfer of wealth from working people to the rich in American history." The Dickson County Democratic Party described Behn as "our very own AOC of TN," referring to "Squad" member Ocasio-Cortez. Although Behn does not post specific issues she supports on her campaign website, she does credit Saul Alinsky's 1971 book, "Rules for Radicals" which outlined his 8 steps to topple a nation, as a motivating factor in her community organizing.

Behn is campaigning against ICE roundups of criminal illegal immigrants, characterizing Enforcement and Removal Operations as "state-sanctioned terror"... "ripping people out of cars for old misdemeanors" and tearing families apart "over paperwork." According to a May 2025 U.S. Immigration and Customs Enforcement news release, among those people being "ripped out of cars for old misdemeanors" by ICE in Nashville was a 37-year-old Venezuelan gang member tied to Tren de Aragua, a 39-year-old Mexican national who had been removed from the United States six times prior and also convicted of domestic assault and statutory rape, a 60-year old Iraqi with a conviction for rape, a 33-year-old El Salvadorian national MS-13 affiliate gang member with drug convictions and an active Red Notice for aggravated murder, and a 36-year-old Haitian national with conviction for possession with intent to distribute methamphetamine. *These* are the individuals that Aftyn Behn prioritizes over the lawful and legal citizens of the 7th Congressional District.

3. Social media influencer and former journalist Katherine "Kat" Abughazaleh (age 26) is candidate for Illinois 9th congressional district (urban and suburban Chicago). Her campaign website proclaims she will do "everything possible to stop the authoritarian takeover of the United States." *I've fought fascists before as a citizen, union rep, and independent journalist. Now, I'm going to do the same in Congress.* Kat's campaign platform includes taxing billionaires and corporations, raising the minimum wage 67% to \$25 per hour, guaranteeing *at least* one year's paid parental leave, providing dramatically increased teacher's salaries and mandating nationwide Universal Pre-K and "All-Inclusive" Universal Healthcare. Kat is very much in favor of providing *at least* a \$3,000 monthly subsidy to stay-at-home parents. Kat supports the Green New Deal and creating a Civilian Climate Corps, banning federal funding of charter schools and overturning the Supreme Courts *Citizens United* ruling in defense of free speech by not restricting the political spending of corporations. She refers to Trump's rhetoric about criminal illegals as "vilifying immigrants" and recently said, "every single person in the world deserves healthcare, even illegal immigrants. How is it controversial?" Last, but not least, Kat believes abortion access is *essential* to healthcare and in providing even more "medical support" and federal protections for the LGBTQ+ community.

The right is coming after trans people for a reason — because they are usually the easiest targets for a fledgling fascist regime to throw under the bus. I can't stress this enough: This has happened before — in early Nazi Germany.

4. Minnesota state Sen. Omar Fateh (age 35) is running for mayor of Minneapolis this year. A Member of the Minnesota Democratic-Farmer-Labor Party, which believes in “progressive land reform” (redistributing land ownership to promote social justice and reduce inequality), Fateh is a self-identified democratic socialist and has been endorsed by the Democrat Socialists of America. In the state Senate, Fateh supported free college tuition for residents, a statewide living wage for Uber and Lyft drivers, state-wide community planning for sustainability and equity and the 100% Clean Energy by 2024 Bill. His mayoral campaign platform includes, raising the minimum wage in Minneapolis 25% over the next three years, passing rent stabilization and tenant protections, investing in non-police programs and, of course, “protecting our City from Donald Trump.”

6. New York State Assembly member Zohran Mamdani (age 34), member of the Democratic Socialists of America party and endorsed by Bernie Sanders and Squad members Alexandria Ocasio-Cortez and Ilhan Omar, handily defeated former Gov. Andrew Cuomo in New York City's mayoral primary in June. Mamdani's platform includes providing fare free city buses, publicly funded childcare and elder care, city-owned and run grocery stores, comprehensive public safety reform, freezing rents on stabilized apartments and increasing the City minimum wage by 82% over the next five years. And of course, “Trump-proofing New York City.” Mamdani has promised to pay for his campaign promises by raising taxes on corporations and the top 1% of New Yorkers and shifting the tax burden from “overtaxed” black and brown homeowners to more expensive homes in richer and “whiter neighborhoods.” Sounds a lot like redistribution of wealth to me...

The War against biological female athletes

The “push-back” continues...

California high school volleyball team with trans athlete sees controversial season end with playoff loss

A nationally contentious season came to an end Wednesday night for a high school girls' volleyball team in California.

Jurupa Valley High School lost their first round state playoff game to Valencia High School in straight sets. The loss, presumably, marked the end of trans athlete AB Hernandez's high school volleyball career.

AB Hernandez, a senior from Jurupa Valley High School, and a biological boy, has been the subject of much controversy since his successful spring track season, in which he won gold in girls' triple jump and high jump, and silver in girls' long jump at California's high school CIF State Track and Field Championships in May 2025. Hernandez out jumped biological female high school athletes all spring, taking podium gold medals away from several female competitors, who had career high performances denigrated by a biological male competitor, forcing them to accept lower placements. At 5-feet, 8-inches and 120 pounds, Hernandez is four inches taller than the average 16 year old biological female, but spot on for the average height of a 16 year old biological male. A 2022 research paper out of the University of São Paulo in Brazil, found that transgender women had about 40% greater muscle mass than cisgender women. They had about 40% greater skeletal muscle mass, were about 19% stronger and had 20% greater cardiopulmonary capacity. The study, published in the British Journal of Sports Medicine, used fifteen transgender women with an average age of 34. All the women had transitioned after the age of 12 and had been undergoing long-term, gender-affirming hormone therapy. Even after 22 years of hormone therapy, meant to block male hormones which increase growth, muscle mass and strength, the transgender females still had a “significant advantage in raw physical ability over women born biologically female.” Additional studies concluded that while male-female transitioners (trans women) do experience a decrease in muscle mass; values for strength and muscle area in transwomen remain above those of biological women, even after 36 months of hormone therapy.

In addition to her championship results in track and field, Hernandez also excelled in girls' volleyball. Jurupa Valley has consistently had strong girls volleyball teams. The team won 21 matches in 2022, the year before Hernandez joined the squad. In 2023, his first year on

the team as a sophomore, Jurupa Valley had 29 wins and followed with 25 wins in 2024. During the 2025 season, Jurupa Valley finished with 21 wins including 10 wins in which opponents forfeited matches rather than to face a biological male opponent on the court. Senior Alyssa McPherson spoke with reporters about the fact that her senior season had been affected by the controversy. “I just feel like it’s so unfair that not only am I missing out on my senior season but my other teammates, our JV team and our freshmen team aren’t playing either ... it’s just so disheartening that they’re not gonna have a season and we just want to be able to compete, play and have fun.”

McPherson’s mother said she’s spoken with the school administrators about the issue facing her daughter and the rest of the program. “I’ve complained multiple times to the administration, and they just disregard our feelings, our position, really. I think they just focus more on one particular student versus the many.” (Tyranny of the minority...)

In 2025, 0.81% of all Americans age 13 and older, (2.85 million individuals) identify as transgender, but 3.28% of all Americans age 13-17 (723,700 individuals) identify as transgender.

Interestingly, that percentage decreases by age group, so that of the national average of all adults age 18+ only 0.81% identify as transgender and . Why is that? Why do adolescents have the highest percentage their age group identifying as transgender? Its scientific fact that the prefrontal cortex – the part of the brain responsible for planning, impulse control, and rational decision-making—doesn’t fully mature until around age 25. This is why teenagers often struggle with emotional issues and have no concept of long-term consequences of the risks they take. Kay Yang was hired to conduct LGBT community outreach and education at a LGBT Center in New York City in 2011. She spent several years visiting local schools and businesses, offering to “educate” kids and employees on gender ideology. In 2018, Yang realized the truth about what she had been doing over the previous six years and became disillusioned with what she then referred to as, “indoctrinating” youth with gender identity. “I had no idea that what I was doing at the time I was being used as a Trojan horse for this like huge marketing campaign [for gender ideology],” she said. “I didn’t know what was going on that was normalizing these policies and these practices that are pushing irreversible medical damage on healthy children” Yang told Fox News Digital in 2023. “I started to realize that what I had been doing at my job at the LGBT Center, it was grooming...” Grooming in this context means “to get into readiness for a specific objective.” “I came to realize what we were doing... years after the fact. I looked back and [thought], ‘Oh my God, what have I done?’” Today Yang fights to prevent young girls from being indoctrinated as she was...

This global agenda to “restructure society” is right out of the Communist Manifesto, the destruction of the nuclear family. Progressive Democrats have made laws over the past four years to protect and promote that minority of the population, making it even easier to expand transgender culture and normalize it to the rest of society. In February 2025, that all changed, as President Trump signed an executive order entitled “Keeping Men Out of Women’s Sports,” and removing the gender category from Title IX that President Biden inserted in 2024. Since then, more and more adolescent female athletes are speaking out about the unfairness of having to compete against biological males. Girls4Sports and Save Girls Sports organizations have sprung up all over the country and female athletes and parents are wearing tee shirts supporting the movement at athletic contests wherever transgender athletes are competing. The fact that the Jurupa Valley Girls volleyball team won 10 of their 21 wins by forfeit shows that Americans will no longer stand silent about what trans activists are attempting to accomplish.

The sad part about all of this, is that there are so many other “useful idiots” out there that have been taken in by trans activism, thinking that they are “standing up for the rights” of a small minority, when in fact they have been indoctrinated just like Kay Yang was.
