Re: Ch. 12 A New Form of ‘Fascism’ for the 21st Century

➤ *Continued Opposition to Donald Trump*

In Chapter 12, *A New Form of ‘Fascism’ for the 21st Century*, I noted that under President Joe Biden, the United States became an active participant in the World Economic Forums *Great Reset* plan. America was the last barrier for global Elites in fully implementing their plan. Schwab and company had wanted Hillary Clinton to be elected president in 2016. Her speech at the 1998 World Economic Forum Annual Meeting in Davos, Switzerland, in which the First Lady called for the “sharing of wealth and power” with “the billions of men, women and children who are effectively without a voice,” was applauded by two thousand of the world’s most influential people.¹ Of course, *they* didn’t want any of *their own* wealth to be shared, they wanted wealth from the middle-class to be redistributed. In a January 5, 2012 opinion piece on the WEF website titled ‘The Hillary Effect,’ Clinton was referred to as “the most powerful woman on the planet.”² Her 2015-2016 presidential campaign platform supported slashing carbon pollution, renewable energy, criminal justice and law enforcement reform, gun control laws, universal healthcare, women’s rights and equality, LGBTQ rights and equality, comprehensive immigration reform and “promoting naturalization,” supporting organized (union) labor and raising the minimum wage.³

Clinton embraced traditional Democrat big government **control** over society and the economy, exactly what global Elites of the WEF were working towards. Opponent Donald Trump campaigned on tax cuts, deregulation, tariffs and renegotiating trade deals like NAFTA, in order to rebuild Americas industrial manufacturing production. Trumps “America First” policies were a threat to global Elites in the United States and around the world, so left-leaning government bureaucrats and U.S. intelligence agencies collaborated in a coordinated effort to prevent Trump from being elected president. When that failed, Democrats in Congress worked to remove Trump from office, impeaching him in the House of Representatives in December 2019.

The Democrat majority in the House of Representatives drafted two articles of impeachment against the president, abuse of power and obstruction of Congress, and voted along party lines to impeach the president on both counts. The charges were centered around the claim that President Trump threatened to withhold U.S. military aid to Ukraine unless newly elected president Volodymyr Zelenskyy pursued investigations into Joe and Hunter Biden’s business dealings in Ukraine while Joe Biden was vice-president. A whistleblower claimed Trump made the threat during a July 25 phone call with the new Ukrainian president, even though he himself was not present during the phone call. The whistleblower cited more than half a dozen other administration officials who overheard the threats. The reason given by Democrats for the alleged threats, was an attempt to discredit Biden, a 2020 Democratic Party presidential primary candidate. The attempt to remove Trump from office failed when he was acquitted on both counts by the Senate in January 2020, also by party-line vote.⁴

In Addenda #39, I gave a detailed account of how U.S. intelligence agencies collaborated with the Clinton campaign to prevent Donald Trump from being elected in 2016.⁵ Although Trump had made claims about this all along, the left-wing media called him a liar and conspiracy theorist, until a document from the Durham report known as the *Classified Appendix*, was found by FBI officials in 2025. The Durham Appendix had been classified by the Biden administration in May 2023 because it proved:

1. The Clinton campaign conspired with U.S. national intelligence agencies to discredit Donald Trump (Russia collusion) before the 2016 election.
2. FBI and Obama administration officials participated in the Clinton campaign plan to discredit Donald Trump in the 2016 election.
3. Senior FBI officials knew the information the Clinton campaign was planning to use against Trump was “likely not credible.”
4. Hillary Clinton personally approved the plan of her foreign policy advisor, Julianne Smith, to “smear Donald Trump by magnifying the scandal.”
5. Clinton campaign advisor Julianne Smith sent the fake Russia collusion information to media outlets herself, knowing the FBI would never release it due to the lack of credibility.

In April 2026, Director of National Intelligence Tulsi Gabbard released secret documents that showed that Michael Atkinson, the Inspector General of the Intelligence Community during that time, had flagged several memos by the whistleblower, a CIA analyst, as having “potential for bias,” and said the analyst had provided false information in his initial complaint to Congress. The now declassified documents from a “closed door meeting” between intelligence agency officials, showed the whistleblower was a registered Democrat who had a professional relationship with then vice-president Joe Biden on Ukraine policy, worked for Democrats on the House Intelligence Committee for more than ten years, and later worked in the Biden White House as a CIA detailee. The documents also showed that the whistleblower met with the Democrat-led House Intelligence Committee working on the impeachment investigation *before* he filed his formal complaint in August 2019.⁶

The documents showed that the complaint was “fast-tracked” by Atkinson as “a matter of urgent concern that appeared credible,” despite knowing about the whistleblowers relationship to Biden and his political bias. They also showed that, like the Clinton campaign plan, the whistleblower report was released by Rep. Adam Schiff’s impeachment investigation committee to the press, even though the Department of Justice found it “relied on secondhand information” and *failed* to meet the departments criteria for “urgent concern.” They showed that the FBI had been warned in 2017 that Schiff approved leaking classified information in order to discredit President Trump over the “Russiagate” scandal, in an attempt to indict him. The documents also showed that the limitations of the whistleblower’s knowledge noted by the intelligence community inspector general, was never included in the letter then-House Intelligence Committee Chairman Adam Schiff released in late summer 2019 that led to Trump’s impeachment in the House of Representatives.⁷

On April 15, 2026, The Office of the Director of National Intelligence general counsel sent a criminal referral to the Justice Department for the whistleblower whose complaint triggered the 2019 impeachment of President Trump. The ODNI also sent a criminal referral for Michael Atkinson, the former intelligence community inspector general, who notified Congress of the allegations. DNI Director Tulsi Gabbard said the whistleblower and Atkinson coordinated the effort to “manufacture a conspiracy.”⁸ Left-leaning news outlets had a different reaction to the referrals, with CNN claiming “Gabbard has used her tenure leading the intelligence community to push political claims by Trump that he was the victim of *false allegations* tying him and his campaign to Russia.”

The Durham report *Classified Appendix* released in July 2025, shows the notes made by U.S. Office of Special Counsel investigators state that the Russian collusion hoax was hatched by the Hillary Clinton presidential campaign to distract attention from her private email server and classified documents scandal and investigation into the Clinton Foundation. Investigators notes also noted that the Obama justice department pressured FBI director James Comey not to release information that would “darken the final part of his presidency and legacy.”⁹ The Durham Appendix shows that “Russia-Russia” collusion, “Russiagate” or “Crossfire Hurricane” were false allegations, contrary to what CNN, MSNBC, abc, CBS and other media outlets still claim to this day.

Whether it’s FBI or CIA agents, U.S. government law enforcement officials, whistleblowers or congressmen like Adam Schiff, it’s a relief that these “deep state” actors are finally facing consequences for their actions. Today, the same Democrats who applauded President Obamas targeting conservative groups for tax audits (IRS targeting controversy) and “de-banking” his political enemies (Operation Chokepoint), or cheered President Bidens DOJ targeting of Pro-Life protestors at the request of Planned Parenthood, classifying parents speaking out at school board meetings against Critical Race Theory and transgender bathroom policies as “domestic terrorists” or the FBI illegally monitoring Republican lawmakers (Arctic Frost investigation), scream how Trump is “weaponizing” the Department of Justice going after his “political enemies.” Ironical, isn’t it?

As of this writing, Donald Trump has been the target of *nine* serious assassination threats or attempts: June 18, 2016; Las Vegas NV, September 6, 2017; Mandan, ND, October 1, 2018 and September 20, 2020; ricin poisoning attempts, July 13, 2024; Butler PA, September 15, 2024; West Palm Beach FL; October 12, 2024; Coachella CA, February 22, 2026; Mar-a-Lago FL, and April 25, 2026; Washington DC. America is considered the top threat to global Elites achieving coordinated control over the worlds citizens, through either the Great Reset or Agenda 2030. Donald Trump, as president of the United States, is the key person standing in their way of the successful implementation of their plans. If Democrats regain control of Congress in November 2026, a third impeachment attempt against President Trump will happen, and everyone in his administration will be targeted in one way or another.¹⁰ Assassination attempts will also continue: Trump is too dangerous to be allowed to remain President of the United States...
