Checks are issued to qualifying organizations in our area making it easy for you to make a difference.


Our 2024 Community Grant Cycle

Each year, we organize a community grant cycle to support initiatives that address the most pressing needs in our area. This year, our grant cycle ran from August 1st to October 1st. During this period, we received a record number of applications. From our endowments, we were able to distribute nine grants, for a total of \$15,000. These grants are awarded to nonprofit organizations to help fund their projects and cover essential expenses, all with the goal of improving our community in the areas of greatest need.

\$2,000 - Allen Regional Transit to help with operational expenses.

\$2,000 - Elsmore Ruritan to fund their food pantry.

\$500 - Hope Unlimited for renovations to their building.

\$2,500 - Humanity House for Christmas food boxes.

\$2,000 - Humboldt Lion's Club to make repairs to their vision screener.

\$2,000 - Iola Middle School to purchase an AED for traveling sports teams.

\$1,000 - Marmaton Valley High School to make renovations to their weight room.

\$1,000 - Moran Youth Recreation to purchase rec equiptment and jerseys for the children.

\$2,000 - Pregnancy and Family Center to fund their project safe with access to car seats and pickn-play bedside sleepers.

Welcoming Our New Funds



Iola Senior Citizens, Inc. Endowment

This agency fund was established to support the Iola Senior Citizens in covering project costs and operating expenses. The fund was initially created by the Senior Citizens with the primary goal of financing their initiative to provide school supplies annually for children in Allen County.



Coach Neil Crane ACC Endowment

This agency fund was founded by Allen Community College to honor Coach Neil Crane for his dedicated years of service as the college's basketball coach. The fundraiser aimed at establishing this fund will enable ACC to name the gymnasium floor in Coach Crane's honor. Future contributions to the fund will support renovations to the ACC gymnasium.

Endowment

The Designated Fund was established by Gary and Barbara McIntosh to provide operational support for the following historical education sites: Fort Lincoln School in Fort Scott, School House No. 9 in Linn County, and the nonprofit Free State Capital.

Match Month



We organized a month-long fundraising campaign aimed at growing our endowed funds. Thanks to the generous support of the Patterson Family Foundation, we were able to offer a proportional match on each donation made to the foundation during the event. The grant allowed us to match contributions up to a total of \$70,000. During the event we raised \$91,580.01, earning the full match, and bringing our total raised to \$161,580.01




Donations Received



Foundation Assets




Foundation By Fund Type
