
### August bike run

# Proposed changes to driving laws

The Westminster government is proposing significant changes to driving laws, with the aim of improving road safety. These changes include mandatory eye tests for older drivers, a lower drink-drive limit, stricter seatbelt rules, and tougher penalties for uninsured drivers. These proposals are part of a broader road safety strategy expected to be published in the autumn:

Mandatory Eye Tests for Older Drivers:
Drivers over 70 could face mandatory eye tests when renewing their licenses. Those who fail the tests may face restrictions or even be banned from driving. This proposal stems from concerns about the eyesight of older drivers and a coroner's criticism of the current licensing system. We raised the issue (amongst others) with Peter McReynolds MLA, Chair of the All Party Group on Road Safety when he visited the Group in February.



Lower Drink-Drive Limit:
The current drink-drive limit may be reduced in England and Wales to align with Scotland's lower limit. This change aims to further deter drunk

driving and improve road safety.

#### Stricter Seatbelt Rules:

The government is considering giving penalty points for not wearing a seatbelt, extending the responsibility to all adults in the vehicle. Currently, only the driver is legally responsible for ensuring passengers under 14 are properly restrained.



Tougher Penalties for <u>Uninsured Drivers</u>:
 The government is also looking at increasing penalties for driving without insurance.

#### Road Safety Strategy:

These proposed changes are part of a comprehensive road safety strategy that the government is expected to release in the autumn.

Responding to this IAM RoadSmart Director of Policy and Standards Nicholas Lyes said: "Given progress on reducing fatal and serious collisions has stalled in recent years, we welcome the UK Government's ambition to publish an updated road safety strategy with the reported measures being a step in the right direction. While many drivers over the age of 70 are safe and competent, health issues and confidence can have an impact on driving abilities, so it is sensible to review whether changes need to be made. We would also support reducing the drink drive limit in England and Wales alongside measures to target drug driving, however these would require significantly more backing for roads policing teams to effectively enforce new laws."

These all look like sensible changes but the question is: when will our Assembly follow suit?

### **Geraldine Transport Museum By Ralph Magee**

On a recent road trip around the South Island in New Zealand, my trusted copy of the Lonely Planet guide recommended visiting the vintage transport museum in Geraldine, a small town set in the rural landscape of South Canterbury, north of Timaru.

The resulting visit left us hugely grateful for the recommendation, but also in awe of the achievements of the volunteers that run the museum. My goodness, what an absolute gem! For those just curious and needing a break from the road, to those with more in-depth knowledge, maybe working experience, of just about any kind of machinery on the planet, this place is a treasure trove.

Collections of chainsaws, single engines for powering tools, bicycles, motorcycles, cars, vans, lorries and tractors fill some 8 sheds. A biplane even graces the roof of one and arrays of household appliances add some domestic colour to the naturally more dominant agricultural machinery.

The collection has the feel of 'we'll take anything, we actually care about machinery of any kind' - a place powered by collective enthusiasm and ambition for preservation; run by volunteers who respect the history of mechanical innovation.

As a genuine community enterprise and therefore even more important to support, I thoroughly recommend the museum to anyone on route 79 heading towards route 1 and on to Christchurch. Going 'the other way', you're heading towards countryside famous for dark skies and incredible stargazing experiences. Geraldine will not disappoint! 
