- 1. Meeting called to order at 10:03 by President Jerry Dunlap.
- 2. Pledge of Allegiance
- 3. Roll Call- Copeland, Dunlap, Gentry, Mortensen, Rego and Stock present. Killen present via Zoom.
- 4. Secretary's Report- Motion by Copeland, seconded by Dunlap, that we approve the minutes of the Board of Directors 01-09-2023 meeting. Passed unanimously.
- 5. Treasurer's Report- Copeland reported that we have \$43,634 in the Operating Account, \$66,570 in Reserves and the loan balance is \$29,117. The annual audit was completed 02-02-2023 and everything was correct and in order. The audit committee thanked DeSpirit for her meticulousness.
- 6. The Executive Committee recently had to address two emergencies- a clogged sewer line and needing to replace the poles destroyed by the 12-25-2022 fire. Maintenance expenditures have also gone up significantly in recent years. They proposed that we amend Rule XXXII as follows (changes and additions in red):

The amount of the Budget and Maintenance Fee is to be voted on by the Board at the December meeting each year. The proposed budget must be mailed to all shareholders in accordance with Article III, D Section 3 of the By-Laws. The proposed budget, with a summary of expenses for the next fiscal year, is to be posted on the Clubhouse bulletin board at least two weeks before the December meeting. In addition, a summary of the expenses for the 12 months, November 1 through October 30 will be posted. In addition,

- A. All contracts greater than \$10,000.00 must be competed with a minimum of 2 contractors when possible.
- B. The Board approves contracts over \$10,000.00.
- C. Approval of maintenance expenditures items not to exceed \$5000.00 and budgeted items in the approved budget may be made by the President or Treasurer.
- D. The Board of Directors having designated an Executive Committee further direct the Executive Committee shall have full authority to exercise all of the powers of the Board of Directors when circumstances and urgent timing dictate the need.

Mortensen moved and Stock seconded that we amend Rule XXXII as proposed. Killen not available during roll call vote but it was otherwise passed unanimously.

The proposed changes to Rule XXVII regarding dock space need further review.

Because we are an RV park, we own the poles, boxes and cans. Power has been restored to 643 Yawl and we are working out details for 635 Yawl. New poles are being installed.

It was reported that while we do have hot water in the men's shower, it does not get adequately to the men's bathroom sink. We will look into this (action item).

It was also mentioned that the hurricane cut to the palm trees is not necessary and can actually be harmful to the palm trees, according to University of Florida Agricultural Services. The palm trees may need to be trimmed only once per year. We will look into this (action item).

The drain on Ketch Circle is still rattling (action item).

There is a 10 week wait for matching pool lounge chairs. It was agreed that we will order a different color for the area outside the pool. We will also look into another table/umbrella (action item).

Pool- Karla Vogel reported the pool's temperature has been increased to 87-88 degrees. The covering/uncovering of the pool by volunteers is running very smoothly.
