BACKGROUND

- A. The Student of the opinion that the Consultant has the necessary qualification, experience and abilities to provide educational consulting service to the Student.
- B. The Consultant is agreeable to providing such consulting services to the Student on the terms and conditions set out in this Agreement.

IN COSIDERATION OF the matters described above and of the mutual benefits and obligations set forth in this Agreement, the receipt and sufficiency of which consideration is hereby acknowledged, the Student and the Consultant (individually the "Party" and collectively the "Parties" to this Agreement) agree as follows:

SERVICES PROVIDED

1. The Student hereby agrees to engage the Consultant to provide the Student with the following services (the "Services"):
 - Professional evaluation of all academic and extracurricular records.
 - Extensive research to develop a realistic list of educational institutions and programs tailored to the student's abilities, interests and needs.
 - Providing guidance with admission applications.
 - Assist the Student in filling-up application forms and all the other documentation. Forward the completed applications and all other documents to the Institutions.
 - Undertake all correspondence with the Institutions, till the receipt of the result from the Institutions.
 - Be accessible to the Student throughout the duration of the Agreement.
 - Respond to the Student telephone calls and e-mails promptly.
 - Assist the Student in obtaining financial aid from the Institutions based purely on Student's merit, academic achievements and the availability of funds in the Institutions, for the semester applied. However, FINANCIAL AID IS NOT GUARANTEED.

TERM OF AGREEMENT

2. The term of this Agreement (the "Term") will begin on the date of this Agreement and will remain in full force and effect until the completion of the Services. The Term may be extended with written consent of the Parties.

PERFORMANCE

3. The Parties agree to do everything necessary to ensure that the terms of this Agreement take effect.

COMPENSATION

4. The Consultant will charge the Student a flat fee of \$350.00 US for the Services (the "Compensation").
5. The Compensation should be paid in full at the time of agreement signing.

CONFIDENTIALITY

6. The Consultant agrees that they will not disclose, divulge, reveal, report or use, for any purpose, any Confidential Information which the Consultant has obtained, except as authorized by the Student or as required by law. The obligations of confidentiality will apply during the Term and will survive indefinitely upon termination of this Agreement.

GOVERNING LAW

7. This Agreement will be governed by and construed in accordance with the laws of the Province of Ontario.
