# Pinal County 2020 Fair Virtual Show & Auction Guidelines



There are 4 different options exhibitors can choose from to compete and sell in the Pinal County Junior Livestock Virtual Show & Auction.

## **Virtual Show & Auction**

Upload required information by Tuesday at 6:00pm. A link will be provided to you via email. One Market entry per exhibitor through Virtual Show and/or Sale. Exception: Exhibitors may sell their Carcass AND their Market animal in the virtual sale.

#### 1.Picture for Auction

Recommended:

- a) Submit most current picture with Exhibitor with Animal
- b) NO FFA/4-H, ASSOCIATION ATTIRE
- c) No previously won awards can appear in the photo.
- d) Picture of just Animal if above not available. Carcass Exhibitors: No picture required

#### 2. Video Submission for Show

- a) Attire: Dark Blue or Black Jeans, Black or Brown Belt, White collared shirt, Closed toed shoes, NO FFA/4-H/Association affiliation or Hats of any kind.
- b) No previously won awards can appear in the video.

### 3. Sellers Agreement

- a) \$20 charge deducted from exhibitor check (normally \$33), plus standard 6% commission fee
- b) \$5 drug test fee will not be refunded as the show is continuing.
- c) Voluntary process sale will go to highest bidder regardless of price. Bidding will start at floor price.
- d) After animal is sold through virtual auction, your animal must be transported to drop off location (to be determined), and premise ID and/or ear tag will be verified at time of receiving, in addition it must be in good health. If any and all of the above are not met, the Exhibitor will be barred from future participation in PCJLC.
  - Executive Board will evaluate case by case basis in the event of accident or loss. Please contact specie superintendent immediately.

- e) ALL SALES ARE FINAL! Any exhibitor or anyone acting for the exhibitor, who is found guilty of asking a purchaser (buyer) to either give their animal back or sell it to them for packer's price or to trade the animal sold for another animal, will be barred from further participation in the Pinal County Fair.
- f) Prices received in the auction ring must be accepted. Acceptance of selling an animal in the auction does not imply or guarantee the sale of that animal for more than the floor price. The specie floor price determined at the start of the auction sets the minimum price for each specie division.
- g) Individual Exhibitor checks will not be released until account is fully funded.

#### 4. Awards

Market Awards (buckles and banners) will be honored and will be distributed at a later date.

## **Virtual Auction ONLY**

Upload required information by Tuesday at 6:00pm. A link will be provided to you via email. One Market entry per exhibitor through Virtual Show and/or Sale. Exception: Exhibitors may sell their Carcass AND their Market animal in the virtual sale.

If Exhibitors do not participate in the virtual show, the market animal will be put to the bottom of the sale order list.

#### 1.Picture for Auction

Recommended:

- a) Submit most current picture with Exhibitor with Animal
- b) NO FFA/4-H, ASSOCIATION ATTIRE
- c) No previously won awards can appear in the photo.
- c) Picture of just Animal if above not available. Carcass Exhibitors: No picture required

## 2. Sellers Agreement

- a) \$20 charge deducted from exhibitor check (normally \$33), plus standard 6% commission fee
- b) \$5 drug test fee will not be refunded as the show is continuing.
- c) Voluntary process sale will go to highest bidder regardless of price. Bidding will start at floor price.
- d) After animal is sold through virtual auction, your animal must be transported to drop off location (to be determined), and premise ID and/or ear tag will be verified at time of receiving, in addition it must be in good health. ## **Virtual Show ONLY**

Upload required information by Tuesday at 6:00pm. A link will be provided to you via email. One entry per exhibitor through Virtual Show.

#### 1. Video Submission for Show

- a) Attire: Dark Blue or Black Jeans, Black or Brown Belt, White collared shirt, Closed toed shoes, NO FFA/4-H/Association affiliation or Hats of any kind.
- b) If animal receives Grand or Reserve, animal <u>must</u> be sold in Virtual Auction.
- c) No previously won awards can appear in the video.

#### 2. Awards

 a) Market Awards (buckles and banners) will be honored and will be distributed at a later date.

# **No Participation in Virtual Show or Sale**

If the exhibitor entered into a private treaty, they will not eligible for virtual sale or virtual show with that animal. The exhibitor will still receive Add-Ons.
