- Awards:

    - Herdsmanship: Banners that are displayed annually.
    - Livestock Judging: Personalizing Banners versus previous awards.

#### **New Business**

- Judge Selection
  - Beef & Holstein Calf contract being signed now.
  - Lamb & Goat contract signed, and W9 submitted.
  - Swine doesn't have a judge secured at this point.
    - President extended due date from November 1<sup>st</sup> (as stated in 2019-2020 Rule Book Section- 5.A) to November 15<sup>th</sup> to have name of judge presented to Committee, and December 1<sup>st</sup> having contracts signed and W9 submitted.
    - If judges are not secured by Friday, November 15<sup>th</sup> the Executive Board will assume responsibility of judge selection.
      - This appears to be a continuous issue, perception is extremely important as we are asking all exhibitors to adhere to deadlines and we as a Committee should model the behavior we expect our exhibitors to show.
    - Motion made by Jaime Bechtell: move for Executive Committee to take responsibility of selecting swine judge.
      - 2<sup>nd</sup>: Casey Farnsworth
      - Discussion:
        - Angelita would like to point out that Steve mentioned his feelings on publishing judges online, and that it shouldn't be made public before the Fair.
        - Michelle Wiese voiced concerns that a large amount of people on the Committee have a vested interest in the pig barn, and that we should have a person without bias make a selection (which would be Michelle as no other Executive Board Member would have potential bias)
        - Wyatt Carpenter stated that a rule was a rule.
        - From hearsay there was one swine superintendent submitted that submitted a list of potential judges, President will research for more information.
