# Board of Directors Report: Corey Brown

- Show Works- Carlos Gomez
  - o Plan to update to newest version of Show Works plan and hope to use it to it's maximum.
  - o Jadee will be running with assistance if needed from Committee Members
- Website- Jadee Rohner
  - o Transferred over from Michelle, Melissa Campbell and Jadee Rohner are working to use it at it's potential for communication.
- Sponsorships- Danielle Tucker
  - o Looking forward to recruiting sponsorships, and providing multiple payment options for sponsors. In addition plan to work together, with a different organization system so the same awards aren't sponsored by multiple individuals.

# Treasurers Report: Carlos Gamez

- Profit & Loss
  - O Not much has changed since last report. Discussed recent changes, renewed liability insurance, payment of judges etc.
- Balance Sheet
  - \$13,000 outstanding from auction (not concerned individuals are aware and will be making payments), expenses foreseen is Show Works, U-Haul Rental, scholarship payments to be made etc.
- Spending Habits
  - Would like to see a simplified process of collecting funds from sponsors, and easing the burden. Would like to see a budget created for each committee, so that last minute spending is avoided.
- Corporation Filings are up-to-date and in the process of completing insurance and sharing with CAFA.

#### Fair Director Report: Misti Todd

- Fairgrounds events are quiet.
- Director of Pinal County Health, mask gatherings are no more then 50 people, he personally didn't see that changing in the near future.
- Cancelling or rescheduling most events at the Fairgrounds scheduled in the Fall.
- State Fairgrounds is approved to have food trucks, concerts etc- so that is a good sign.
- Locally & Nationally- Christmas Light Parade in Casa Grande is cancelled, Denver Stock Show is cancelled and the NFR is moved to Texas.

- There are also a large amount of club t-shirts from the 2020 Fair in the Office, so urge leaders to pick up at their convenience.
- Carlos: Spectator vs non-spectator event.
  - o NFR moved to Texas, World Series is a non-spectator stayed in Vegas.
  - o Has their been any discussion to spectator to non-spectator events?
  - o Misti: It's happening, but ultimately comes down to anything over 50 people is not "allowable" due to last Governor mandate.

#### Call to Public

- Chloe Van Haren
  - o Presented by Corey Brown: Question from Chloe Van Haren in breeding division, can you have a breeding doe with horns or not?
  - o Corey Brown will not be making decisions on his own, without board or committee input.
  - o Tracy Anders: Rule Book states no horns, although other shows allow breeding goats with horns. The purpose of breeding does horns is for protection in the herd. She doesn't have an issue with allowing the breeding doe to participate with horns.
  - o Chloe Van Haren: Breeding does don't get killed at the end of the year, which is why they typically have horns so they aren't bullied in a herd. Market goats get killed at the end of the project.
  - O Corey Brown: In Section 4.C it states "All other rules and regulations apply the same in the breeding and feeder classes as in the market divisions." Referring to 13.3 it states that "Market goats must be dehorned/disbudded prior to ear tagging dates and healed completely prior to fair receiving- with scurs no more than 1" at fair horns of no more then 1" at scur at Fair."
  - O Corey Brown: Discussed topic as an executive Board, and we are in agreeance that we need to follow Rule Book, and if it's not up-to-date with industry standards then it need to be a Rule Change submitted at the appropriate time (which would be the annual rule change committee meeting)

# **New Business**

## 4-H Participation is in Phase 0 and at this time completely virtual

- 4-H is under the umbrella of University of Arizona, Cathy Martinez has submitted an official request to allow in-person meeting for upcoming PCJLC events so 4-H members may participate.
- Carlos Gamez: As a 4-H leader of a large swine 4-H group, states that members must be able to meet- it's essential and if unable to meet through 4-H then they will move to their group to Association. He is unsure about other options.
- Victor Jimenez: Suggested calling Marie Melendez at the Casa Grande Extension Office for approval of individual events.
- Mike Norris: As the Signal Peak leaders, they need to go through the re-certification process, and is looking for support from the County level due to the time it takes to complete the re-certification
- Victor Jimenez: Is hopeful that in the next 2 weeks we get approval from the University to start to open up events at the local level. Empathizes that the time it's taking, and that are just as eager to get started as well.
- Travis Hartman: Needs answers ASAP.
- Victor Jimenez: Meeting with Cathy Martinez tomorrow, and will look for answers immediately to concerns brought forward.

- Jake Myers: Expressed the concern of having 4-H retract members abilities at the time of Fair, and advised that all 4-H groups move to Association.
- Corey Brown: 4-H Leaders have some decisions to make in the upcoming weeks.

- Jadee Rohner: Denny Daniels is the Association Superintendent, and would be able to advise on requirements for Association groups to form.
