## LEAD & COPPER RULE MONITORING AND REPORTING VIOLATION MANDATORY LANGUAGE - TIER III

## IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER

**OAK HILL ACRES MOBILE HOME SUBDIVISION (PWS 0150156)** has violated the monitoring and reporting requirements set by Texas Commission on Environmental Quality (TCEQ) in Chapter 30, Section 290, Subchapter F.
