### City of Paisley Special Council Meeting Minutes of April 28, 2025

1. <u>Call to Order</u> Pursuant to notice published on the city website: <u>www.cityofpaisley.net</u>, and notice published at the Paisley Post Office, the Paisley Merc and given to members of the Council, the Special Council Meeting of the City of Paisley was held on April 28, 2025, at 705 Paisley City Hall. President Stu Burgess called the meeting to order at 6:39 pm. Council members in attendance were Stu Burgess, Travis Garner, and Craig DeLarm via phone. Others in attendance were Melissa Walton, recording minutes.

#### 2. Business

- 2.1 Drilling a Well at the Paisley Arena Melissa explained she had been contacted by Matt Withers concerning the well at the arena. There is a well driller currently in town, drilling for the Wither's Ranch. Mr. Buckner is willing to work with the city on the fee for the drilling and payment schedule. Travis said he would like to see if there is a permit required before we begin. Craig stated that as part of the fire department, he will have to haul 3500 gallons of treated city water out to the arena for stock water every week this summer. Both expressed concern about PYRA and other rodeo people being willing to utilize the arena without any water present. They would also both like to see the baseball diamond being utilized. Craig stated there are people from Lakeview who want to come out and play. Stu expressed concern about the rush to get it done, worries that community members may not be happy with the decision. Craig stated the community has always supported the rodeo grounds and baseball diamond being utilized. Travis Garner made a motion to drill a well out at the Paisley arena for stock water, Craig DeLarm 2nd. Voting yes: Stu Burgess, Craig DeLarm, Travis Garner. Voting nay: none. Motion carries. Travis is going to check on the permit requirements. If one is required, the project will be postponed.
