Regular Council Meeting
Minutes of Feb 2nd, 2026
6:30 pm at City Hall

- **Call to Order** Pursuant to notice published on the city website: www.cityofpaisley.net, and notice published at the Paisley Post office and given to members of the Council, the Regular Council Meeting of the City of Paisley was held on Jan. 12th, 2026, at Paisley City Hall. Mayor Keith Harra called the meeting to order at 6:32 pm. Council members in attendance were Stu Burgess, Craig Delarm, Len Babb III, and Trina Negus. Others in attendance were Travis Way, Earl Faunce, and Shelia Babb, recording minutes.

- **Consent Calendar** Keith Harra entertains acceptance to approve Jan. 12th, 2026, minutes. Stu Burgess makes a motion to approve minutes, Len Babb III 2nds the motion. Voting aye: Keith Harra, Stu Burgess, Craig Delarm, Trina Negus, Len Babb III. Nay: none; motion carries.

Keith Harra entertained acceptance to approve Jan. invoices, Len Babb III makes motion to approve the Jan. invoices, Stu Burgess 2nds the motion. Voting aye: Keith Harra, Craig Delarm, Len Babb III, Trina Negus, Stu Burgess. Nay: none; motion carries.

- **Business:** Duane Graham's plan for trailer park is tabled until next month.
- Mosquito Festival update, Stu Burgess said they had a good turnout of people. Some new ideas have been floated around. Maybe bring back the basketball tournament and looking at musicians. Next meeting maybe Feb. 24th @ 4:30 pm. Keith Harra wants maybe a Committee Chair elected. Stu Burgess wanted it to be known that he wasn't taking over the whole committee just wanted to get it started.
- Craig Delarm wants to set up his Food Truck here at the Community Center maybe twice a week. He said he would pay a fee for electricity. The council agreed he could pay \$40.00 a year. He's thinking of opening from 10-2 pm. Trina Negus thought it was a great idea, Keith and Len agreed. Stu Burgess motioned to approve Craig Delarm's request to set up his Food truck twice a

week, Trina Negus 2nd the motion. Voting Aye: Len Babb III, Keith Harra, Trina Negus, and Stu Burgess. Nays: None motion carries.

- School Greenhouse: Contractor out of Redmond is doing the work. Gave council all the permits needed. Keith Harra found no issues with the setbacks. The school is going to have classes for the students and sell plants and stuff. Keith Harra entertained the motion to approve the permit. Stu Burgess makes the motion to approve the permit Craig Delarm 2nds the motion. Voting Aye: Keith Harra, Len Babb III, Trina Negus, Craig Delarm, and Stu Burgess. Voting Nay: None; motion carries.
- Well Update: City only had 1 bid for the test well and it was from Jones Well Drilling company, and it was for \$482,225. It will be a full functioning Well except the pump and the house around it. Most bids for a Well this size are well over the amount that is in the bid. The hope is to have better water if we dig deeper. Next step is do a notice of intent to award them the contract. They have 15 days to sign and send back then we have 10 days to receive and go forward. Keith Harra entertains motion of intent of award, Stu Burgess motions to accept contract, Craig Delarm 2nds the motion. Voting Aye: Keith Harra, Len Babb III, Trina Negus, Craig Delarm, and Stu Burgess. Voting Nay: None motions carries.
- Keith Harra gave an update on the property at 661 Mill Street; he found out that the occupants have bypassed the meter and are stealing city water. He wants to pursue civil penalties.
- Table the vector control until next month.
- **Public Appearances:** Earl Faunce asked if the city plans on paving Marshview; Keith Harra said yes, we wanted to do that sometime this year. We have grant money that needs to be used for that before April 2027. Earl also was wondering about a better way to plug into electricity for the bouncy houses during mosquito festival at the school, city offered use of our generator if need be, but he would have to go to the school board.
