Regular Council Meeting
Minutes of July 6, 2026
6:30 pm at City Hall

- **Call to Order** Pursuant to notice published on the city website: www.cityofpaisley.net, and notice published at the Paisley Post office and given to members of the Council, the Regular Council Meeting of the City of Paisley was held on July 6, 2026, at Paisley City Hall. Paisley Mayor Keith Harra called the meeting to order at 6:30 pm. Council members in attendance were Len Babb III, and Stu Burgess via Zoom. Others in attendance were Lori Mayea, Eugene Beachler, Gary Clark, Donna Long, Rachel Cooper and Shelia Babb, recording minutes.

- **Consent Calendar:** Keith Harra entertained a motion to accept minutes, Len Babb III motioned to accept the June 1st and 15th meeting minutes, Stu Burgess 2nds Voting aye: Keith Harra, Len Babb III, and Stu Burgess. Voting nay: none; motion carries. Len Babb III motions to accept the Invoices for June, Keith Harra 2nds. Voting aye: Len Babb III, and Keith Harra. Stu Burgess abstains since he didn't have the Invoices to look at. Motion carries.

- **Business:** Highway signs near the city park, Stu thought maybe a suggestive sign rather than a No Parking Sign. The corner is dangerous for pedestrians. Does the city have to have permission from ODOT to put signs up? Maybe City could be liable for injuries if no signs in place. Keith suggested to ask city lawyer and LOC lawyers to see what they thought. Tabled until next meeting to see what lawyers and ODOT say. Commercial Businesses – Eugene brought up that the businesses in town are not paying commercial water rates. It is in the Ordinances that the businesses shall pay commercial rates. Stu thought they would conserve more if they didn't have commercial rate, but Keith disagrees, why have commercial rates if they aren't paying commercial rate. Len Babb III motioned to charge the Commercial Businesses the commercial water rate according to the City Ordinances,

Keith Harra 2nd the motion. Voting aye: Len Babb III, Keith Harra, and Stu Burgess. Voting nay: none, motion carries. Takes effect in September 2026.

Mosquito Festival Update: Missy Walton made a poster that got put on the webpage, Safeway gave 2 gift cards that bought all the ribs and soda. Donations are coming in, waiting on a few more. They have Travis Riddle band for Friday and Sat. Night. Lora Mayea had the Quilt Show flyers; Shelia will put them on the website. Having kids' games and adult games on the lawn. - **Public Comment:** Rachel Cooper asked permission for the Paisley Rodeo Club LLC, to use the Arena for Mosquito Festival weekend. She said they are having Jack Rabbit Dogs food trailer and Honey Bee mobile bar there. Keith Harra motioned to accept the use of the Arena, Len Babb III 2nd. Voting aye: Keith Harra, Stu Burgess, and Len Babb III. Voting nay: none; motion carries. Gary Clark asked if the City generator was working yet, Keith said “no”, we are working on that with the EPA grant funds when they get ready to do the construction for the pump house.
