PLEASE READ CAREFULLY

Non-medical masks or face coverings are mandatory to be worn in all indoor spaces and outdoors when physical distancing of 2 metres / 6 feet is not possible.

Reservations – limited – prepaid in advance and non-refundable.

Requests accepted between 9:30 am – 4:00 pm Monday thru Friday not on weekends.

- All visitors are required to complete the reservation request form including waiver, found on our website. Requests must be emailed only , minimum 48 hours in advance of visit. You will be notified by email of your confirmation only if your request is successful.
- Our online availability calendar, on our website, will be current and up to date, please check availability before beginning reservation process.
- Sail-ins only call 905-468-3966 upon arrival for availability, registration and waiver process if successful
- Inside dockage is not guaranteed.
- **No docking assistance available – ensure you are comfortable docking your own boat.**
- Gatherings are not permitted on docks and walkways.
- Visitors are asked to utilize their onboard facilities as much as possible.

Services:

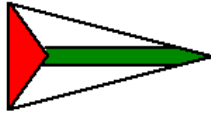
- In accordance with Provincial regulations Clubhouses are closed

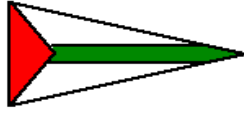

Visiting Boater ACKNOWLEDGMENT, WAIVER and AGREEMENT

I _____ *print name* (hereinafter called the "Visitor") hereby **ACKNOWLEDGES** that despite the steps and precautions taken by NOLSC, its staff, its membership and its Board of Directors (individually or collectively the "NOLSC Parties") the use of NOLSC's facilities entails some risks given the nature of COVID-19 and that the risk of becoming exposed to or infected by COVID-19 may result from actions, omissions, or negligence of Visitor or others, including, but not limited to, NOLSC Parties and / or other NOLSC Visitors. In consideration of the opportunity to use NOLSC facilities, the Visitor hereby;

1. AGREES to assume all risks, including the risk of exposure to COVID-19, and the risk of contracting COVID-19 ("COVID-19 Risks") while visiting NOLSC facilities,

2. ACKNOWLEDGES receiving NOLSC's COVID-19 Policies and Code of Conduct that have been implemented to help reduce COVID-19 Risks and to comply with all valid requirements of government bodies having jurisdiction ("COVID-19 Measures") and

AGREES to comply with such COVID-19 Measures,

3. ACKNOWLEDGES that it has provided all others who will be travelling with Visitor to NOLSC facilities on Visitor's boat ("Visiting Boat Crew") with NOLSC's COVID-19 Measures and this Acknowledgement, Waiver and Agreement and has obtained their agreement to comply with such COVID-19 Measures and all terms and conditions stated herein as if they were signatories hereof,

4. ACKNOWLEDGES that a failure to comply with any COVID-19 Measures by the Visitor or Visiting Boat Crew may result in the Visitor and Visiting Boat Crew being required to leave NOLSC immediately and denied further access to NOLSC facilities,

5. AGREES not to bring any claims for injury, loss, or damages against NOLSC Parties including without limitation any claims arising out of or relating to exposure to and/or contracting COVID-19 (any "Claims"),

6. AGREES to indemnify NOLSC Parties against any Claims which may be made by any of the Visiting Boat Crew,

7. AGREES to refrain from visiting NOLSC facilities while they or any of the Visiting Boat Crew may be exhibiting any COVID-19 symptoms or during any period during which the Visitor or any of the Visiting Boat Crew should or must be in quarantine or self-isolating based on orders, and / or guidance provided by government or public health officials, or while knowingly infected with COVID-19, and

8. ACKNOWLEDGES that in making the choice to visit NOLSC facilities it has agreed to fully abide by the terms specified herein and that it either has obtained independent legal advice before signing this document or has irrevocably waived its right to do so.
