
Aurora protested Battlestar Pegasus for failure to keep clear under Rule 10. A collision occurred with serious damage to Aurora. Great Laker Series, Race 4. August 24, 2022.

Facts Found						
The incident occurred during the first upwind leg of the race.						
Aurora was sailing upwind on starboard tack. They had been on starboard tack approximately 10 minutes.						
Battlestar Pegasus was sailing upwind on port tack. They had been on port tack approximately 10 minutes.						
Aurora thought Battlestar Pegasus saw them sailing on starboard tack and would keep clear.						
Battlestar Pegasus did not see Aurora until their mainsail was in front of them. There was no opportunity to avoid collision.						
Battlestar Pegasus hit Aurora on the port quarter, damaging their stern pulpit and cockpit coaming, and breaking their primary winch and winch base off which were lost overboard.						

Battlestar Pegasus admitted fault and that they had failed to keep clear as port-tack boat.

Battlestar Pegasus continued racing. They completed a two-turn penalty on a later leg of the course and

Aurora hailed that they were protesting and immediatelyy retired from the race.

Conclusions and Rules that Apply

Battlestar Pegasus on port failed to keep clear of Aurora on starboard, and broke RRS 10.

By delaying her two-turn penalty to a following leg of the course, Battlestar Pegasus failed to comply with the requirements of RRS 44.2.

Since Battlestar Pegasus caused serious damage by her breach, her penalty was to retire as required by RRS 44.1(b).

Decision

Battlestar Pegasus is DSQ in Race 4, Great Laker Series.
