Glacial Pomeranians LLC has no control over what the puppy may come in contact with once he / she leaves here. Because of this, no guarantee is made against infectious disease.

THIS PUPPY WILL BE TAKEN TO AN ARIZONA STATE LICENSED VETERNARIAN AT THE SELLERS EXPENSE TO HAVE A DETAILED HEALTH EVALUATION DONE WHEN IT IS 7 WEEKS OLD.

ALL ITEMS LISTED BELOW WILL BE ASSESSED BY THE VETERNARIAN. RESULTS WILL BE IN A WRITTEN STATEMENT, SIGNED AND DATED BY THE VETERNARIAN:

- BITE WILL BE CHECKED FOR CORRECT BITE, OVER BITE, UNDER BITE, MALOCCLUSION***
- SKIN WILL BE CHECKED FOR FLAKES, DRY SKIN, LESIONS, GENERAL CONDITION***
- COAT WILL BE EVALUATED, COLOR OF COAT WILL BE RECORDED***

- ***PUPPY WILL BE CHECKED FOR PARASITES, CONFIRMED PARASITE FREE BY FECAL EXAME***
- ***HEALTH OF EYES WILL BE EVALUATED FOR DISCHARGE, CHERRY EYE, GOOD SIGHT ETC.***
- ***HEALTH OF EARS WILL BE EVALUATED FOR NORMAL HEARING, CLEAN EARS, MITE FREE***
- ***SKULL WILL BE EXAMINED TO CHECK FOR OPEN FONT***
- ***HIPS WILL BE CHECKED***
- ***HEART WILL BE CHECKED***
- ***LUNGS WILL BE CHECKED***
- ***PATELLAS WILL BE EVALUATED AND GRADED***
- ***VET WILL CONFIRM NO HERNIAS***
- ***VET WILL CONFIRM CORRECT REPRODUCTIVE EXTREMITIES (VULVA / TESTICLES)***

Buyer agrees not to take puppy to places where other dogs frequent to limit exposure to infectious diseases until 3 weeks after the full series of shots are completed. All puppies will be up to date on vaccinations and worming when they leave here and it is the buyer's responsibility to ensure that puppy receives any further vaccinations. In no case will breeder be responsible for buyer's vet bills for puppy.

BUYER AGREES TO HAVE THE PUPPY VACCINATED AGAINST:

Canine 1-DAPPv (DA2PPv) prevents Canine Distemper, Adenovirus Type 1 (Hepatitis), Adenovirus Type 2 (respiratory disease), Parainfluenza, and Parvovirus..... EVERY THREE WEEKS BY A LICENSED VETERINARIAN UNTIL THE PUPPY RECEIVES LAST VACCINATION AT 18 WEEKS OLD.

The puppy will be up to date on vaccinations and worming and treated for possible internal parasites before going to their new home. Please discuss this with your veterinarian at the initial puppy exam. We also do not vaccinate for leptospirosis you can talk with your local veterinarian to decide if you need it for your area. There is a high incidence of reaction with leptospirosis vaccines so unless you have an issue with it where you live, we do not recommend vaccinating for it.

IF PROOF THAT THIS PUPPY WAS VACCINATED FOR THE ABOVE ITEMS IS NOT PROVIDED, THIS REPLACEMENT GUARANTEE WILL BE VOIDED.

PLEASE NOTE: TO KEEP BITE CORRECT, PUPPY TEETH THAT DO NOT FALL OUT ON THEIR OWN BY 6 MONTHS OF AGE WILL NEED TO BE PULLED BY A STATE LICENSED VET.

Breeder / Seller does not assume any liability for any injury to said puppy after the buyer receives the puppy. Buyer must take the puppy to the vet for a puppy check within 72 hours of receipt of the puppy.

A three year from birth "replacement warranty" is given for any life-threatening genetic disease that causes said puppy's death within three years.

As attested to in a necropsy report by a state licensed veterinarian procured by buyer and reviewed by Breeder/ Sellers ARIZONA State Licensed Veterinarian if the puppy should expire, Buyer must provide written documentation from their vet after having a necropsy performed at the buyer's expense, that the death was in fact caused from a genetic defect.

The puppy's microchip number must match the microchip number given to the puppy at the time of the necropsy is performed on the puppy.

In the case where I replace a dog with a genetic defect that has not died, said dog needs to be returned to the breeder / seller as an exchange for the replacement. A replacement puppy may be from a different litter at a later date or from different parents. A Replacement is the only option, we do not give cash refunds PLEASE NOTE if Buyer decides to have the puppy treated for illness instead of returning puppy for exchange, Breeder/Seller will not be held responsible for any veterinary bills or replacement puppy and this guarantee becomes VOID.

Warranty does not cover open fonts. Buyer will be made aware of an open font that has not yet closed before sale of the puppy. An open font is the equivalent of a baby's soft spot and is from the plates on the head not closing yet. These are quite common.

Open fontanelles are a normal finding in very young puppies. As normal puppies mature, the growth plates in their skull fuse together and the soft spots known as open fontanelles gradually reduce in size until they no longer exist. Persistent open fontanelles, however, are a common genetic condition that is seen in some small dog breeds, including Chihuahuas, Miniature Dachshunds, Pomeranians, Shih Tzus, Yorkshire Terriers, Maltese, Lhasa Apsos, and Pekingese. In these dogs, persistent open fontanelles are caused by genetic abnormalities in normal developmental skull closure.

The growth plates in these dogs simply fail to fuse in a normal manner, leaving a persistent soft spot in the skull. Open fonts should eventually close and require no special care other than common sense of not allowing a puppy to injure its head. For example, do not leave a puppy unattended on a couch or any surface off the ground where they could possibly fall onto their head. Do not drop them on their head, or drop anything on their head.

Glacial Pomeranians LLC assumes no shipping costs associated with the sale or replacement warranty. Glacial Pomeranians LLC cannot and does not guarantee a specific size that said puppy will be at maturity. Size and weight can be affected by diet and exercise as well as genetics.

Upon the purchase of one of our puppies and circumstances change in your life that make keeping Him or Her. Buyer will return the Puppy to Glacial Pomeranians LLC. Along with signed AKC Paper relinquishing ownership to Glacial Pomeranians LLC. Buyer agrees never to Put The puppy in a shelter, Foster care, Or Rescue of any kind. Buyer will return the puppy at buyers expense.

Buyer is aware that Glacial Pomeranians LLC will not give cash back for or repurchase the puppy. The Buyer is aware that they are giving the puppy back to Glacial Pomeranians LLC with no cash back of any kind. Buyer agrees that the return of the puppy is in the puppies best interest.

Breeder / Seller does their best to estimate approximate adult size based on several factors as well as past experience.

Warranty only applies to the original buyer of this puppy and is not transferable.

We only accept cash in US currency. We do not accept checks, money orders, cashier's checks. We suggest that the buyer pick up their puppy from our home. If buyer cannot pick up their puppy, we can provide buyer with transport options with a flight Nanny/Transport Nanny.
