#### 137 Organ Donor Heroes

137 patients were able to donate an organ towards lifesaving transplant or research during 2023. The number of donor heroes has nearly doubled since 2020, when CDT facilitated 76 donors.

Pictured is one of our donor heroes from 2023, Jaimison Hall. "Jaimo" tragically passed in May 2023 and saved 6 lives through his gift of life. His recipients include a 1 year-old (heart) and 1 month-old (liver). Scan the QR code below to read his story.



361 Transplant Recipients

Our donor heroes provided **361 organs for lifesaving transplant**. This included 187 kidneys, 83 livers, 46 lungs, 31 hearts, 13 pancreas, and 1 intestine.

Pictured above is one of our transplant survivors, Tyler Mejorado. He was diagnosed with liver cirrhosis at only 6 years old. He became so ill he needed to go on life support. Tyler ultimately received a transplant and is now in his 20's, attending Fordham University with a dream of going to law school! Scan the QR code above to read his full story.




#### The U.S. Transplant System

46,632 transplants were performed in the United States in 2023 thanks to the selfless and generous gifts from more than 16,000 organ donors. 2023 marked the 13th consecutive year of record donation increases. ### 2024 Quality Improvement Initiative Eliminating Missed Organ Donation Referrals

#### Over 300 Missed Organ Referrals Identified Across NY & VT

CDT's quality improvement team conducts death record reviews on all referrals to determine compliance with medicare's required referral rule. In 2023, CDT found over 300 cases where organ donation referral was not made when previously indicated. In these cases, patients were terminally extubated without any prior notification to CDT. Because referral was not made, no organ donation opportunity was available for respective patients and their families.

#### Referral Triggers

Medicare law is what mandates referral to Center for Donation & Transplant when death has **occurred** and previously, when death is **imminent**.

The two keywords relate to potential for donation:

Occurred- Once death has been declared, call CDT within 60 minutes. Since perfusion is no longer maintained, only tissue and eye donation can be evaluated for. If a patient qualifies to donate, ConnectLife and Lions Eye Bank will offer tissue donation to the patient's family, with up to 24 hours of time that can pass from the time of death to the time of procurement. Imminent- If a patient is on a ventilator with an end-of-life injury, GCS ≤ 5 or anticipated withdrawal of care, referral must be made to CDT as soon as possible, prior to any termination of ventilatory or medical support. Since the ventilator continues to supply oxygen and perfusion is maintained, an evaluation for organ donation takes place after an "Organ Donation Referral" has been made. If a patient qualifies, a CDT staff member will offer donation to the patient's family. See below for a organ referral badge card.




Any consideration of de-escalation of care, DNR or withdrawal of any life sustaining therapies
