Over 20 years ago, Teller Senior Coalition (TSC) was created by concerned community leaders in response to Teller County's decision to stop providing certain services to local seniors.

“The intrinsic goal of TSC is the improvement of senior's capability to remain in their own homes as long as possible while maintaining independence and dignity.

The services we provide support this goal.

To provide services to Teller County senior citizens to enable them to live full, active, and independent lives.



WELCOME

Greetings,

The Teller Senior Coalition had another year of continued growth in 2017. Our mission remained to provide services to Teller County senior and disabled citizens to enable them to live full and active lives emphasizing wellness, independent living and social interaction. These services are crucial for the community to “age in place”. With the age group of over 65 expected to double in Teller County by 2020 from 3,100 persons to approximately 6,200. The demand for our services will continue to increase.

Ourservices: transportation, case management, caregiver respite, home delivered meals, and handyman work increased by 8 percent. Our growth is better represented when comparing 12,717 services provided in 2015 with 17,567 services provided in 2017 which is a 38% increase.

Notable events this year included a fundraiser which raised nearly \$5,000. And once again TSC received an annual award from the Colorado Association of Transit Agencies (CASTA). This year it was for the best Human Services Agency.

I'd like to express my gratitude to all of our supporters who make these donation-based services accessible to Teller County residents. That support coupled with our hard-working staff, dedicated corps of volunteers and involved Board of Directors, enables Teller Senior Coalition to continue its commitment to meet the growing needs of the community. OUR SERVICES

Transportation:

TSC provides our clients with assistance to essential services for seniors 60+ (medical appointments, shopping, banking, pharmacy, etc.). We provide transportation assistance for disabled citizens, qualified Medicaid recipients, and clients under 60 for medical appointments.

TSC provides weekly delivery of frozen or shelf stable meals. We provide nutritional education and counseling.

Our handyman services help seniors with minor home repairs and installation of safety devices such as grab bars.

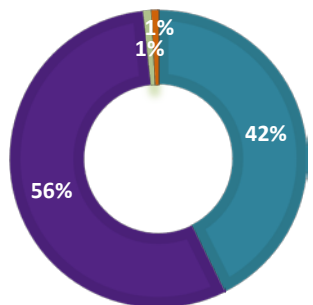

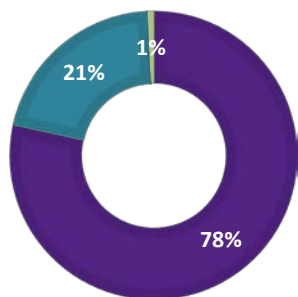
