Chrysalis Personal Training LLC and the Member are collectively referred to as the "Parties" and individually as "Party".

Chrysalis Personal Training LLC offers personal training and group fitness classes, community events, and other services. The Member wishes to participate in Group Fitness Classes. By signing this agreement, the member understands that they may participate in up to THREE fitness classes of any kind each week.

1. Member Access

This Agreement entitles the Member to access Chrysalis facilities (hereinafter referred to as "Facilities") as long as the dues are paid. Access includes participating in up to three fitness classes each week, scheduled personal training sessions, and community events organized by Chrysalis Personal Training LLC and it's representatives.

The Membership facilities provided by Chrysalis are as follows:

One Complimentary Personal Training Consultation

Group Exercise Classes (Maximum 3 each week)

2. Membership Fees

The Member agrees to subscribe to Chrysalis Group Fitness Membership and will pay an amount of \$180.00 (hereinafter referred to as "Fee") on the 5th of each month, unless agreed upon by Chrysalis Staff and the Member.

NOTE:

- 1. Monthly memberships are paid in advance monthly, on the calendar date the membership has started, for the following month.
- 2. Yearly membership has to be paid in 1 lump sum, or in equal monthly installments. If you decide to pay in equal monthly installments, your payment is due on the 5th day of each month.
- 4. A late fee of \$40.00 will be charged post 10th of each month if the payment is not made in time. **Note any Membership adjustments below:**

Payments will be made in person, virtually, or over the phone by contacting Chrysalis Personal Training LLC, following the link provided on the website, or in any other agreed upon way.

3. Term

The Membership shall commence immediately upon agreement to these terms and conditions and shall continue till the Member pay the fee on time or until it is terminated by either Party.

4. Right to Cancellation

To cancel their membership without penalty, the Member has to inform Chrysalis Personal Training LLC in writing or email within 7 days after signing this Agreement. If the Agreement is canceled within 7 days, Chrysalis shall return to the Member all amounts paid minus \$30 for the usage of the Facility during those 7 days.

5. Membership Freeze Policy

Member may freeze their yearly membership for up to 60 days in one calendar year during which time you will not be charged the usual membership fees. A fee of \$100 shall be charged per freeze request. A Freeze is effective only upon 7 days prior written notice to Chrysalis before the Freeze is to take effect. The freeze request must state both the freeze start date and membership resume date. Once you resume any usage of Chrysalis and it's facility, the freeze will terminate and the monthly charge will resume. The time of any freeze will extend the Yearly Membership term by the amount of time of the freeze.

6. Termination

The Member may terminate this Agreement upon 30 prior written notice to Chrysalis. Upon the termination of this agreement, the Member shall immediately return to Chrysalis, any material issued to the Member. Chrysalis may charge the Member a fee of \$20 for any material issued to the Member that is not returned within 7 days of the date of termination.

This Agreement may also be immediately terminated in the event there is a breach of the terms of this Agreement by either party. This Agreement shall also terminate upon the death of the Member, or because of significant physical or medical disability for a period in excess of 3 months.

If the Member has prepaid the membership fees for a specific number of months, Chrysalis shall refund any remaining balance to the Member, after deducting the outstanding amount owing by the Member, within 30 days after the date of termination.

7. Assumption of Risk and Potential Liability

The Member acknowledges and agrees that there are risks involved with any fitness and physical activity, the use of exercise equipment, and participation in an exercise program, and such risks may include the risk of serious bodily injury or death.

By signing this agreement, the Member knowingly and voluntarily assumes all risks of liability, loss, illness, death, or injury caused or arising out of any use of the Facilities or the participation in any activities by the Member.

8. Lost Goods

Chrysalis Personal Trainnig LLC takes no responsibility for lost or stolen goods. Lost and found goods not claimed after 14 days will be donated to charity or thrown away.

9. Damages

The Member shall pay for any damages it incurs to the equipment or premises of Chrysalis Personal Training LLC, which results from the poor conduct of the Member or its guests.

10. Rules and Responsibilities

The Member shall abide by all the safety guidelines and regulations as set forth by Chrysalis while using the facilities or equipment of the service.

Consumption of drugs, alcohol, tobacco, or similar addictive substances must be strictly prohibited at the fitness facility provided by Chrysalis Personal Training LLC.

Breaking into fights that involve physical injuryor not shall not be permitted at any cost and must result in either suspension or termination of membership.

Member is expected to update their membership status on a monthly or yearly basis.

Members must respect each other in all circumstances and should take care of the instruments or equipment after every use.

Persons under the age of 18 are not permitted in the fitness area unless otherwise agreed upon by staff.

11. Arbitration

In the event of any dispute arising in and out of this Agreement between the Parties, it shall be resolved by Arbitration. Determined by Chrysalis Personal Training LLC and it's representatives. The Arbitrators' decision shall be final and will be binding on both the Parties.

12. Miscellaneous

Indemnification: The Member must indemnify the Gym harmless of any and all claims, loss, injury, or damages without limitation, as the membership shall be serving as a liability release for the Member.

Binding: This Agreement shall be considered binding upon the Member and the Gym. Any and all legal proceedings in lieu of the Agreement shall be resolved by the jurisdiction laws of the state of Arizona.

Notices: Any and all notices, apart from cancellation notice, can be made to the Parties through Email or a certified mailing address as mentioned in the Agreement. Any additional address shall be notified to the Parties in writing and in person.

Governing Law: This Agreement hereto shall be governed and interpreted in accordance with the laws of Arizona.

Entirety: This Agreement and other annexures, therefore, constitute the entire agreement between the Parties with respect to the matter of subject hereof and thus, supersedes all prior agreements, purchases, understandings, and negotiations, written or phonated, between the Parties.
