



THE US "PREPPER" EXPLOSION



This group of Americans, fearful of "Doomsday" has more then doubled in size since 2017, to over 20,000,000 people. This embrace of a prepping culture reflects the deeper, growing anxieties linked to US political polarization & social divide. This community includes a growing number of Ultra High Net Worth families who are buying up sanctuaries abroad in anticipation of "the event", i.e. "doomsday" in some form. Because of distance from perceived doomsday events, the two destinations most asked about in the US are (1) Alaska, (2) NZ. With food for survival being a major concern, many see a rural NZ agribiz asset as a doomsday sanctuary with food & safety.

- ☐ The increasing issues associated with climate change and its negative impact on agriculture and food production is the major issue for Americans planning to survive "doomsday" in a bunker.
- Many who come into our realty office in Ft Lauderdale, tell us that they think New Zealand is the best place to go because of its remoteness and world leading agricultural sector which will produce all the food they will need for survival in a NZ agribiz sanctuary.

CURATED LAND BASED PACKAGES



OIA Consent Exempt

With no OIO consent required, income producing orchards up to 5 hectares in size enable a shorter S&P timeframe.

This is the category that the "Showcase" focuses on, Catering to the growing pool of HNW investors across America wanting to own a safe "trophy" sanctuary for the family with USD5M+ being a starting point.

OIA Consent Required

Over 5ha requires OIO consent. This can stretch the S&P process out to a year or more.

Larger income producing agribiz assets in the **USD10M+** category. Typically purchased by **UHNW** families as legacy assets with all trading passing through into a family's US tax structure.

NZ RESIDENCY:

To support NZ residency applications that demonstrate "economic benefit to NZ", all curated packages will include a minimum investment of not less than USD1M into a post-seed capital, early-stage, regional NZ agribiz or agritech company seeking "angel" expansion capital.

CURATED SEED STAGE VENTURES



There are many seed & early-stage ventures in NZ that could be funded with foreign capital that would support the NZ Investor Visa Application process.

AGRIBIZ CAPITAL

While New Zealand is globally renown for its agricultural sector, there is a paucity of early-stage capital providers to bring many innovative concepts to market ready. A situation not helped by the challenges faced where Māori land is a component in a capital delivery equation. Private, foreign investment should be directed towards this need.

AGRITECH CAPITAL

Covering the spectrum from food growing through the harvest phase and into integrated, value adding, there are a vast number of opportunities available for foreign investors to come into all four spheres of New Zealand's "Natural Capital" economy. i.e., agriculture, apiculture, horticulture and aquaculture all open exciting investment avenues.

Investments that provide capital to Māori led, early stage agribiz ventures supports the NZ Reserve Bank's policy of creating access to capital for Māori entrepreneurs to help build greater economic resilience in the heartland.

"OUR" SHOWCASE CASH FLOW








