***Transitioning to In-House Counsel and Human Resource/Employment Issues to Consider for Ohio New Lawyer Training***  
An introduction to in-house counsel differences will be discussed including transitioning, social differences, employment litigation tactics as well as the different laws and expectations regarding anti-discrimination. The statutes discussed will be the Family Medical Leave Act, Fair Labor Standards Act, and Title VII of the Civil Rights Act of 1964. Also dissected will be *McDonnell Douglas Corp. v. Green*, 411 U.S. 792 (1973).

Cases are *Middendorf v. Middendorf*, *Eikleberry v Eikleberry* and *Munroe v Munroe*. Statutes are ORC 3127.18, ORC 3113.31, ORC 3105.171 and Franklin County Domestic Relations Court LR 13(E).

***Ohio Workers' Compensation Law-Hearing Process for Ohio New Lawyer Training***  
In-depth overview of Ohio Workers' Compensation Law regarding specifically the administrative hearing process. We will briefly discuss the entire workers' compensation system in Ohio from the injury allowance to medical and compensatory benefits to the claims processing structure at the MCO/ADR level, Bureau of Workers' Compensation, Industrial Commission of Ohio, and further litigation in the Ohio courts will be discussed. Necessary filing forms, such as C-86, C-9, C-11, R-2, etc. as well as Ohio Revised Statute 4123 will be examined. *State ex rel. Dillon v. Indus. Comm.*, 2024-Ohio-744 will be discussed.

Schoessler's Supply Room, L.L.C., 190 Ohio App.3d 1 (2010). Various chapters of the Ohio Revised Code, Title LIX, will be discussed including (but not limited to) Chapter 5903 "Veterans Rights."
