## **Supplemental Bylaws**

If you attended the AGM in 2019 and stayed for the Special General Meeting, you will remember that 16 supplemental bylaws were voted in favour of by the membership. Unfortunately, those bylaws were not approved by the Director of Utilities as they were. The bylaws have been rewritten and resubmitted to the Director for a pre-approval before the membership votes on these again. Included in the AGM package you will receive a full list of 15 Supplemental Bylaws along with a Notice of Intentions. They will also be posted on the website.

## **AUDITOR INFO**

At the 2021 virtual AGM, the following motion was made: "The board of directors solicits at least three quotations from accounting firms that may have REA experience, including Feddema & Company and that the board of directors then is empowered to decide which firm to retain for the 2021 financial statements."

## **AGM Information**

Tomahawk REA Annual General Meeting is open to Tomahawk REA members in good standing (those with a board-approved contract) and board of directors guests only. For landowners without a board-approved contract, the deadline to become a member will close on Friday, April 22nd at 4:00 p.m. If you have received a newsletter that has been stamped INCOMPLETE CONTRACT, please contact the REA at 780-514-8732, or you will not be able to attend the meeting.

The meeting is open to members only. All parties on the land title are invited to attend - one voting card will be issued for each member in good standing.

Upon registration, all voting members will receive their AGM booklet, voter card, ballot exchange card and a ticket for the \$100 energy draw.

There is one director position open for election. This is your opportunity to nominate and elect a director you feel will best represent the interests of the REA.

IMPORTANT: The membership will have an opportunity to vote on 15 supplemental bylaws. A complete Notice of Intentions, as well as the 15 proposed Supplemental Bylaws, will be sent in your AGM package to the last known address you have on file. If you would prefer to pick up your package at the office, call the REA to make arrangements.

A presiding officer will be available from 5:00 p.m. to 6:30 p.m. to answer your questions concerning the procedures of the AGM.

Those with outstanding or incomplete contracts will not be able to attend. The Tomahawk REA Board of Directors has requested a purchase offer from FortisAlberta for the REA's electricity distribution assets.

In the fall of 2021, FortisAlberta presented an offer to the Tomahawk REA Board of Directors proposing to purchase the REA's electric distribution system for \$10.5 million or approximately \$15,000 per service. The Board has agreed to present this offer to the membership and is proceeding with information sessions for all Tomahawk REA members.

The resulting distributions from the Fortis Sale will be taxable at a personal level in the hands of each individual member. The Proceeds will be taxed differently for each member depending on each persons individual situation. As tax season is upon us, now would be the time to discuss with your accountant how the proceeds of the sale could affect you if the Tomahawk REA voted in favour of selling to FortisAlberta. Tax implications could include tax on Capital Gains and claw back of Old Age Security to name a couple of factors you should discuss with your accountant.

All members are free to purchase electricity services through TREA's regulated rate tariff or from a retailer of their choice. The delivery of electricity to you is not affected by your choice. If you change who you purchase electricity services from, you will continue receiving electricity from TREA. ## **DIRECTORS POSITION**

Nominations for the Director position will be handled as follows:

- Acceptance of Nomination
- Each Nominee will have three minutes to speak before voting begins. A short board meeting will be held immediately after the annual general meeting for the appointments of the new director and selection of the chair and vice-chair positions.

Director responsibilities include but are not limited to:

- One (1) board meeting per month except for December
- Volunteer time to complete tasks arising out of board meetings
- Three-four (3-4) possible additional meetings throughout the year; dependant on needs of both the board and membership
- Training in governance and other matters as required
- Completion of the Code of Conduct
