Foreign influence is no longer a distant or theoretical threat. From covert lobbying and shell-company investments to farmland acquisitions near military sites, closing our borders or vulnerabilities in critical technology, **state legislatures have become the front line of America's national security.**

At State Shield, our mission is to work directly with policymakers to fortify state defenses by protecting supply chains, advanced technologies, critical infrastructure, agriculture land purchases and businesses, and our nation's natural resources from adversarial control.

Enclosed you will find our **2025 State Shield Legislative Scorecard**, which highlights the significant work our States have undertaken to safeguard America's security and sovereignty. This inaugural Scorecard evaluates state-level actions taken to counter the escalating threats posed by foreign adversaries - particularly the Chinese Communist Party - to our nation's economy, security, and values.

This first-ever edition honors two statewide achievements: "**Governor of the Year**" and "**State Legislature of the Year**". Nominees were selected from the eleven states where, during the 2024–2025 legislative cycles, State Shield advanced landmark reforms. These states include Alabama, Arkansas, Florida, Georgia, Iowa, Louisiana, Mississippi, Missouri, Nebraska, Oklahoma, and Tennessee.

To fully capture the scope of the COVID and post-COVID period work done, the inaugural **Scorecard** evaluated the five-year period from 2021 – 2025 only in the states where we were actively engaged in promoting legislation, executive orders, resolutions, and other actions taken by constitutionally elected offices to strengthen state and national security. Beginning in 2026, State Shield's Scorecard will transition to an annual review of legislative activity.

During the 2025 Legislative Session State Shield's work spanned 11 States. For Sessions commencing 2026 we will expand to 17 States as we add Indiana, Kansas, Montana, New Hampshire, South Dakota, and South Carolina. For year 2027 we anticipate further expansion to Alaska, Idaho, Nevada, North Dakota, Ohio, Texas, Utah, Vermont, Virginia, West Virginia, and Wyoming—ensuring every state has the tools, resources, and information needed to confront these rapidly growing threats.

America's resilience begins at the state level, and with thoughtful leadership, we can ensure our nation continues to remain strong, free, and secure.
