Mutual Aid Box Alarm System

MABAS (Mutual Aid Box Alarm System). Polk Jackson Perry Fire District has established a mutual aid response system for fire, EMS, and specialized incident operational teams. The Following guidelines shall be used when requested by department OIC. The attached alarm boxes are to show which order departments, and which equipment, are to be dispatched in the event of a major incident. If a department is requested and unable to fulfill the assignment of the mutual aid request then the next department in line of the equipment should be dispatched. IE Nankin Fire is requested for a tanker for a 2nd alarm mutual aid, but they are unable to provide the tanker, after 2 tone outs or notification to the dispatch center that they are unable to fulfill the request. The next tanker listed on the alarm should be dispatched in Nankins place.

EMS Mutual Aid Box:

EMS Mutual aid box is to utilize the departments at the bottom of each box alarm sheet. OIC will advise dispatch of the need for additional squads, and how many. Dispatch will then request the squads as listed. If the department is unable to provide the request after 2 tone outs the next department in order should be dispatched.

Brush/ Wildland Fire Mutual Aid Box:

Brush or wildland fires will use the same mutual aid box alarms as listed previously for structure fires with the following changes. In Lieu of dispatching an Engine the listed department will be dispatched for a tanker, and in lieu of dispatching a tanker the listed department will be dispatched a brush truck.

Description of the alarm boxes are below.

- **Box 34-1:** Extends from the Northern border of the coverage area South to Township Road 902 to include the North side of Township Road 902. From the Western border of the coverage area East to County Road 175 to include the West side of County Road 175.
- **Box 34-2:** Extends from South side of Township Road 902 South to the intersection of County Road 1302 and State Route 89. And from the Western border of the coverage area East to County Road 175 to include the West side of County Road 175.
- **Box 34-3:** Extends from South side of the intersection of County road 1302 and State Route 89 South to the Southern border of the coverage area. And from Western border of the coverage area East to County Road 175 to include the West side of County road 175.
- **Box 34-4:** Extends from the Northern border of the coverage area South to North side of State Route 604. And from the East side of County Road 175 East to the Eastern border of the coverage area.
- **Box 34-5:** Extends from South side of State Route 604 South to the Southern border of the coverage area. And from the East side of County Road 175 East to the Eastern border of the Coverage area.
