

**2024 WARREN ITALIAN AMERICAN FESTIVAL

Welcome pageant participant!

The Warren Italian American Festival presents the **2024 Tiny King and Queen and Tiny Prince and Princess Pageants on Saturday, August 10th at 3:00 PM**. Please read this document carefully as some of our procedures have changed from previous years.

The Tiny Prince and Princess Pageant is open to 4 & 5 year olds and the Tiny King and Queen is open to 6 & 7 year olds. Contestants from prior years may enter as long as they were not awarded the same title for which they are competing. Contestants must submit a copy of their birth certificate upon registration to confirm their age.

**There are TWO rehearsals this year.**

- Saturday, August 3rd from Noon - 1:00 at the Warren Fred Astaire Dance Studio in the Elm Road Giant Eagle Plaza.
- An onstage rehearsal is scheduled for Friday August 9th at 10:30 on the Festival mainstage. (Time subject to change pending weather.)

Contestants compete in their Italian Fun Fashion outfit. This may be formal or casual but should be your interpretation of festive Italian heritage attire. No props please. Please take into consideration the heat. We want your child to be comfortable and happy. The participants will learn a group song in Italian. This will be emailed to you by July 10th so you can begin learning the words and tune. This will not be judged. The contestant bio will be completed during rehearsal on August 3rd.

Please plan to participate in the parade on Sunday, August 11th. Winners should plan to find their own vehicle, but are encouraged to ride with their counterpart. For example, the King and Queen can ride together and the Prince and Princess can ride together.

**Deadline to enter is July 10th.** *Your spot in the pageant is reserved when we receive your application, photo, photocopy of the child's birth certificate and non-refundable \$40 entry fee.* Your pageant t-shirt is included in your fee. Checks should be written to the Warren Italian American Festival Committee. No fees will be accepted at rehearsal this year. Your photo and birth certificate will be returned to you.

Contestants must be of Italian descent by either parent. 3.) Contestants must attend rehearsal. 4.) Contestants from prior years may enter as long as they were not crowned the title for which they are competing. 5.) Decision of the judges is final. 6.) Contestants are entitled to recognize one sponsor during the pageant. 7.) Contestants will compete under their first and middle names. 8.) The pageant committee are volunteers and have no input in the outcome of the pageant. Harassment of committee members will result in expulsion from future pageants.
