**AN ORDINANCE APPROVING AN AGREEMENT
BETWEEN THE VILLAGE OF MILLINGTON AND GROOT, INC.
FOR RESIDENTIAL SOLID WASTE SERVICE**

WHEREAS, the Village of Millington ("Village") is an Illinois municipal corporation lawfully organized and existing under the Constitution and laws of the State of Illinois, including, without limitation, the Illinois Municipal Code (65 ILCS 5/1, *et seq.*) ("Code"); and

WHEREAS, the Code (65 ILCS 5/2-2-12) authorizes the Village to enter into agreements and to take other acts necessary to exercise its statutory powers; and

WHEREAS, it is necessary for the Village to contract for various services from time to time; and

WHEREAS, the Village wishes to enter into the Agreement attached as Exhibit A ("Agreement") with Groot, Inc. ("Groot") to allow Groot to collect, haul, and dispose of solid waste produced by single-family homes and townhomes located in the Village; and

WHEREAS, the Village will benefit from the Agreement by ensuring that the Village's residents can access quality refuse removal and disposal services; and

WHEREAS, the Board of Trustees of the Village of Millington find that approving the Agreement will benefit the public health, safety, and welfare by supporting sound refuse disposal practices; and

WHEREAS, Groot has reviewed the Agreement and wishes to approve it; and

WHEREAS, the Village has reviewed the Agreement and wishes to approve it; and

NOW, THEREFORE, BE IT ORDAINED by the Village President and Board of Trustees of the Village of Millington, Kendall and LaSalle Counties, Illinois, as follows:

Section 1: RECITALS. The foregoing recitals are incorporated as though fully set forth herein.

Section 2: APPROVAL. The Agreement attached as Exhibit A is approved, subject to Village Attorney approval.

Section 3: AUTHORITY. The Village President and Village Clerk are authorized and directed to execute the Agreement, and the Village President is authorized to take any and all actions necessary to implement and enforce the Agreement's terms.

Section 4: REPEAL. All ordinances, resolutions, or parts thereof in conflict with this Ordinance are hereby repealed to the extent and only to the extent they are in conflict with this Ordinance.

Section 5: EFFECTIVE DATE. This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
