SB-91 To amend Part 1 of Article 1 of Chapter 18 of Title 45 of the Official Code of Georgia Annotated, relating to the state employees' health insurance plan, so as to prohibit the Board of Community Health from entering into, executing, or renewing a contract or contracts with any pharmacy benefits manager that owns or has an ownership interest in any retail pharmacy

**B**-112 To amend Chapter 1 of Title 10 of the Official Code of Georgia Annotated, relating to selling and other trade practices, so as to extend certain protections for consumers relative to warranties of HVAC systems and components of such systems; to allow for transfers of

certain manufacturers' warranties of HVAC systems and components of such systems; to prohibit manufacturers', distributors', and retailers' warranties of HVAC systems and components of such systems from being conditioned upon product registration

**SB 2** Relating to the imposition, rate, computation, exemptions, and credits for state income tax, so as to exclude tips from taxation.

**SB 24** Relating to general provisions relative to ad valorem taxation of property, so as to provide for an extension of preferential assessment periods for certain historic properties.

SB 45 & SB47 Relating to preferential assessment for bona fide conservation use property and bona fide residential transitional property, so as to increase the maximum acreage to qualify for assessment and taxation as a bona fide conservation use property

**SB 52** Relating to ad valorem taxation of property, so as to authorize certain local governing authorities to provide temporary tax relief from the taxes levied for the harvest or sale of standing timber in certain disaster areas.

**SB 59** Relating to preferential assessment for bona fide conservation use property and bona fide residential transitional property, so as to remove a limitation on leased property as to certain entities.

**SB 89** Relating to income taxes, so as to increase the amount of a tax credit based on the federal tax credit for certain child and dependent care expenses to 40 percent of such federal tax credit; to provide for a child income tax credit.

**SB 46** Relating to general provisions relative to state government, so as to improve government service delivery in this state; to provide for the appointment of a State of Georgia Government Service Delivery Lead within the Georgia Technology Authority to coordinate such efforts; to establish the powers and duties of such individual; to establish the heads of each state agency as responsible for the government service delivery of their agency and provide for related powers and duties.

**SB96** To modernize and update provisions creating certain boards, panels, authorities, centers, commissions, committees, councils, task forces, and other such bodies.
