Mr. N Subramanian ("NS") welcomed the members to the meeting. The meeting then commenced with the introductory note from the Secretary.

- **A)** The members were briefed on the background of the registration of the Trust. The Samajam was registered as a Trust in the year 2017 with an objective for further development by mobilizing funds from various sources and promote spiritual and charitable activities on a wider scale. Soon the plan would be to get the Trust registered under the Income Tax Laws and avail the benefits there from. This would also benefit our Donors with 80G deduction in computing their Income Tax.
- **B)** Trust Membership and Fees: The Membership scheme of the Trust was launched. There are 2 types of memberships for the avail of members.
  - Annual Membership
  - Life Membership

Fee structure will be as follows:

Annual Membership @ Rs. 1,000 per year.

Life Membership - Onetime payment of Rs. 10,000

"Patron" status shall be provided to members making contribution of Rs. 15,000 or more.

### C) Maintenance of Sundara Vinayagar Temple, AVM Avenue, Virugambakkam:

It was brought to the notice of members that the Samajam is contributing Rs. 35,000 (approx) annually towards maintenance of the temple and the following activities:

- Monthly Uthiram Aaradhanai
- Panguni Uthiram Pooja
- Vinayaka Chaturthi Celebration
- Mahaperiyava Annual Aaradhanai
- Vishu festival
- Contribution for safekeeping and Pooja of the idol of Lord Dharmasastha

Members were informed about the monthly Aaradhanai on Uthiram every month. The form for registration for the Pooja has been circulated to the members. Members who wish to participate in the Pooja to provide the details in the form. The contribution to be made shall be Rs. 1,000 per person per annum. Members to register in the form and remit the amount through Cheque, Bank Draft or NEFT.

# E) Introduction of 1008 Hundi Program:

1008 Hundis shall be released from the Samajam. 25 Hundis shall be made the responsibility for each member. Members may further circulate the Hundis to friends and family. An offering of Rs. 2 per day can be made to each Hundi every day. The filled in Hundi is to be deposited annually during the Laksharchana Festival. The funds from the Hundi shall be maintained as part of the corpus fund of the Trust.

- **F)** Annual Expenditure of Trust Mr. Mohan, Treasurer gave an overview of the total expenses being incurred on various activities of the Trust on an annual basis. Expenses for the year 2018-19 amounted to Rs. 16.5 Lakhs (approx). Considering inflation, the estimate for the year 2019-20 is Rs. 18 Lakhs. Members took note of the same.
- **G) Sabari Yathra Makara Vilakku 2020:** The Secretary gave an overview of the plan for Sabari Yathra in January 2020. Budget for Sabari Yathra 2020 shall be Rs. 10,000.
- **H)** Chennaiyil Sabarimala: Mr. N Subramanian thanked the members for the participation and support extended for the "Chennaiyil Pamba" special Pooja which was conducted in December 2018. He further informed the members about the plan to host a special Pooja "Chennaiyil Sabarimala" in December 2019 at 'SUBKALYAN', Saligramam, Chennai. He also invited suggestions for various activities to be conducted as part of the Pooja from the members. After consideration of the same, the final plan for the Pooja along with the invitation shall be circulated in due course.
- I) Plan for meetings: Meetings of members shall be held once every Quarter (3 months). Additional meetings may be called for to make important announcements as required. The next meeting will be conducted for the release of the 1008 Hundis and launch of the 1008 Hundi program. The date and venue shall be communicated in due course.

The meeting concluded with thanks to NS for hosting the meeting at his residence and all the members for their participation.
