## **COUNCIL MEETING OF THE FEDERATION : KOLKATA (W.B.) ON 25.11.2022**

The Council Meeting of All India State Bank of India Staff Federation was held on the 25th November 2022 at Kolkata to discuss the agenda items as per the Notice. The council meeting was chaired by Com.Arun Bhagoliwal, President. Com.Sanjeev K. Bandlish-General Secretary, Com.G.Kripakaran-Sr.Vice-President and Com.P.K. Baishya-Sr.Vice-President were also present on the Dias.

Com.Arun Bhagoliwal welcomed all present in the meeting hall and advised the house that this meeting is being held after a gap of 4 months, the earlier meeting was held at Amritsar on 28th July 2022. Further, Com.Bhagoliwal added that concluding programme of Platinum Jubilee Celebrations of the Federation will be taking place on 26th November 2022 and we all should feel proud to be part of the celebrations. Com.Bhagoliwal thanked Kolkata Circle General Secretary and the entire team for all the arrangements which have been organised by them.

Com.Goutam Neogy, General Secretary, SBISA, Kolkata Circle came to the Podium and asked comrades of Bengal Circle to felicitate the dignitaries sitting on the Dias. Thereafter, Com.Neogy welcomed and thanked everybody present in the hall.

Com.Arun Bhagoliwal initiated the proceedings of the council meeting and asked Com.Sanjeev K.Bandlish-General Secretary to continue with the Agenda.

Com.Bandlish welcomed all to the City of Joy-Kolkata and advised the house that this council meeting is being held today just a day before when concluding programmes of Platinum Jubilee Celebrations and Centennial Celebrations of State Bank of India Staff Association(8 Circles) will be taking place on 26th November 2022 at Nazrul Mancha, Kolkata with great pomp and show. It is going to be the important day in the History of State Bank of India when Chairman-SBI, DMD(HR) & CDO, CGM(HR) alongwith HR team from Corporate Centre and Ms.Christy Hoffman, General Secretary-UNI GLOBAL, Nyon, Switzerland shall be attending the programme.

Comrades from Bengal Circle presented flower bud each to all the council members present in the hall.

Thereafter, the General Secretary took up the agenda seriatim:

### **Agenda 1.: To confirm minutes of the Council Meeting held at Amritsar on 28th July 2022.**

The minutes of the council meeting held at Amritsar were presented before the house and read out by the General Secretary and the house approved the same with great applause.

**Agenda 2.:To apprise the house about the latest development at the Bank/Industry Level.**

Com.Bandish stated by saying that this meeting is being held after of gap of 4 months and since then no Central Bipartite Meeting has taken place with the Corporate Centre, so there is no much considerable developments. While talking on Industry Level issue, he advised that issue of 5 days banking has been discussed in length at UFBU level and a letter in this regard has already been sent to Indian Banks Association and the entire information has since been disseminated by way of Circular also.

**Agenda 3.:To apprise the house about the Charter of Demands for the 12th Bipartite Wage Settlement.**

The General Secretary advised the house that Charter of Demands duly approved at Amritsar Council and as approved in NCBE Central Committee was sent to 4 Unions of UFBU. After detailed deliberations Charter of Demand for the 12th Bipartite Wage Settlement has been submitted to Indian Banks Association on 21.10.2022 copy of which has already been circulated to all by way of Circular.

**Agenda 4.: To discuss about the General Council Meeting of NCBE.**

The General Secretary advised the house that the last General Council of NCBE was held at Nashik on 2.10.2015 and now the General Council of NCBE has been scheduled to be held on the 5th February 2023 at Panchkula near Chandigarh.

Everybody present in the hall gave a thumping roar with great applause thereby coopted Com.Philip Koshy and Com.Akhilesh Mohan as Sr.Vice President(s).

Thereafter, both the comrades were given a befitting welcome by presenting bouquets by Com.Arun Bhagoliwal, Com.Sanjeev K.Bandlish, Com.G.Kriparakan, Com.P.K. Baishya and Com.Goutam Neogy.

Few Comrades came up for seeking clarifications and giving suggestions on various topics viz. Com.H.C. Rajath-outsourcing at LCPCs, issue of online Holiday Home booking, staff recruitment, Com.Santosh Haldankar-Entertainment and newspaper allowance for outbound sales force, nursing charges not being paid in case Hospitalisation, standardisation of charges in case of Tie-up Hospitals, Com.Soji Damol-Graduation increment for all, NPS including perks, Com.Shailesh Yadav-As Bank is insuring loan taken under IHLS, similarly Overdraft Limit also be insured by the Bank. Also in case both the spouses are working in SBI their individual IHLS limits of Rs.60 lacs each should be clubbed thus making a total eligibility to Rs.1.20 Cr. Similarly while car loan is to be availed by both spouses their individual limit of Staff Car Loan be clubbed together thereby making total availability of Rs.20 lacs, Com.K.V.S.N. Murthy-while encashment of LFC, in case of senior citizen dependant members only concessional fare is being paid whereas Railway Site shows no concessional fares, Com.Mahesh Gosawi-Under Uniform Transfer Policy in case a female/male staff is transferred out of centre while they were of 53 years/54 years age they should be made eligible for repatriation as soon as they attain the age of 54/55 years, regarding 5 days banking issue-30 minutes in the evening should be agreed, Com.Sumit Nandy-outsourcing of jobs to be protected for regular jobs, ex-gratia-educational facilities 3 yers for Graduation and 4 years for Technical course, Com.Maninder K. Shukla:ICT, Outsourcing, Canteen Boys serving for more than 25 years can be converted to subordinate cadre, Com.V.Bhawani Prasad-Drop down box not showing if anyone was on administrative transfer/redeployment.


At this Com.Bandlish took up the mike and replied to all the queries of the comrades to their complete satisfaction.
