PAYMENT OF SALARY ARREARS OF 10TH AND 11TH BIPARTITE SETTLEMENT TO EX-SERVICEMEN COMRADES

Few of our Ex-servicemen Comrades who had filed Writ Petitions in the court against withdrawal of MSP component by the Bank, were not paid salary arrears of 10th and 11th Bipartite Settlement.

In one such case, the Hon'ble High Court of Allahabad has directed the Bank to release the payment of arrears by obtaining an Undertaking from the petitioners.

In view of the above, all our Ex-servicemen comrades, who are not in receipt of Salary arrears of either 10 th BPS or 11 th BPS or both, may furnish the Undertaking in the attached format and forward a copy to their respective controllers and CM, HRMS through Branch Manager, for release of arrears.
