We invite applications from all eligible wards/students of the members in the format enclosed hereto for considering the grant of awards, both under Scheme-I and Scheme-II for the Academic year **2023–2024**. The rules under Scheme-I and Scheme-II are appended to this circular. The duly filled in applications, complete in all respects, should reach this office on or before **30.11.2024**.

SCHEME - I

The wards of members who have come out successful either in SSLC/10th Standard under CBSE/ICSE or II PUC examination in the first attempt as a regular student in a school/college situated in Karnataka and who have secured the minimum percentage of marks as shown hereunder shall be eligible to apply.

NOTE: 10 awards each to be reserved for Science, Commerce and Arts subjects with a Rider that if sufficient applications are not received in any category, the same can be transferred to another category.

SCHEME - II

The wards of members who secure 75% and above marks in **GRADUATION** (or) **POST GRADUATION** examinations viz. Science, Commerce, Arts, Medicine, Engineering, Finance and other professional courses, if any, as recognised by the Universities or Government, subject to maximum of 5 awards under each category, as a regular student in a college situated in Karnataka shall be eligible to apply for payment of award under the scheme. The amount of award will be **Rs.5,000**/-(Rupees five thousand only) under each category.

- NOTE: i) Marks Cards issued by the concerned Board/University is to be enclosed along with application for both the schemes.
 - ii) A member promoted from Subordinate cadre to Clerical cadre will be eligible to apply under Subordinate Cadre' also.

Members whose act attracts the provision of Bye-law No.9 of the Union or who are in arrears of subscription even for a month/Levy to the Union shall not be eligible to apply for the award for their wards/students.
