CENTRAL COMMITTEE MEETING HELD ON 29.07.2024 : CHANDIGARH

The Central Committee of National Confederation of Bank Employees convened on the 29th July, 2024 at Hotel Park View, Sector-24, Chandigarh, under the Chairmanship of R.Balaji, President, along with Com. Sanjeev Kumar Bandlish, Com. Arun Bhagoliwal, Com. Milind Nadkarni, Com. L. Chandasekhar and Com. R. Sriram where in the undernoted decisions

Com.Sanjeev Kumar Bandlish, General Secretary commenced the proceedings by 2. reading out the minutes of the previous Central Committee Meeting held on 05th February 2023 at Panchkula and the house approved the same with big applause.

The General Secretary then apprised the house of the latest developments at the 3. Industry level and successful signing of 12th Bipartite Settlement with IBA. Com.Bandlish further elaborated the highlights of the 12th Bipartite Settlement for which the house gave a exuberant applause.

Thereafter, the Committee unanimously approved the accounts of NCBE for the 5. calendar year 2022, 2023 and Financial Year 2021-22 & 2022-23 and financial statement of expenditure for the period 01.04.2024 to 25.07.2024.

Com.Bandlish advised all the members of Central Committee to form the State Units 6. wherever those have not been formed and asked the State Federation to conduct the meetings as and when it is due to strengthen the State Federation and asked them to give full support to the minority unions working in their State.

7. The Agenda regarding Principal Positions in NCBE (Working or Retired) was discussed at length, with all the Federating Unions presenting their view points. It was decided to give mandate to Com. Bandlish to elect a new General Secretary of NCBE after finalisation of General Secretary position of AISBISF. All the affiliates of NCBE unanimously decided that the General Secretary position of both NCBE and AISBISF should be with the same person adhering to the long-standing practice of the organisation.

Subsequently, Com. L.Chandrasekhar, SBI Staff Union Amaravati Circle has been elected as General Secretary of All India State Bank of India Staff Federation as well as General Secretary of National Confederation of Bank Employees in the delegate session of AISBISF on 30th July, 2024 at Crystal resorts, Chandigarh.

8. Affiliation to NCBE was granted to the SBI Gold Loan appraisers Union, Amaravati Circle and SBI Outsourcing And Casual Employees Union, Amravati Circle, A.P, functining in Amaravati Circle.

9. All the affiliates highly acknowleged the remarkable and commendable services and invaluable contributions rendered by Com.Sanjeev Kumar Bandlish, General Secreetary since 01.05.2016 to till date. The house acclaimed about the achievements of Com.Sanjeev Kumar Bandlish in 11th & 12th Bipartite Settlements, Family Pension, imporvements in Pension, removal of tapering of DA and Ex-gratia to pensioners etc.

In his closing remarks, Com.Sanjeev Kumar Bandlish, General Secretary commended the reception committee for the exceptional arrangements, ensuring a comfortable stay and smooth conduct of the meeting.
