Retired officers are also engaged at RACPCs/CPCs/Branches for miscellaneous/ clerical jobs.

As an Organisation, we are opposing the outsourcing of messengerial/clerical job. In order to address this sort of unfair labour practice and to avoid frauds, we require complete information on the practices followed at the Branch/Office.

We request all our Members/Local Secretaries to submit the information as per the format overleaf, immediately. In any case, within a week's time, to enable us to proceed further in the matter.
