Executive Directors Report (5 Min)

<u>COVID / BASS Update</u>: While the governor has lifted the mask mandate, we decided to follow the school districts lead regarding mask requirements for Direct Services. We will also continue to follow COVID data in Pueblo County as a tool for future decision making regarding Direct Services. We expect that as cases continue to decrease and the positivity rate continues to be below the 5% benchmark we envision removing the mask requirement in direct services in the coming months.

As for ITC & West 2nd, the mask mandate has been lifted.

<u>New Resources</u>: As previously reported, the State Budget includes 667 new enrollments. The new resources will come with funding for capacity building for case management. The amount is \$1,191 per person. This amount is based on historical figures plus an inflation adjustment.

<u>Alliance Report</u>: Alliance's biggest priorities continue to evolve around provider sustainability, the elimination of subminimum wage over a multi-year timeline, and the passage of a bill to move Medical Client Transportation regulations from the Public Utilities Commission over to HCPF, so we don't lose IDD transportation access, among other legislative and budgetary efforts Alliance is working on.

ALLIANCE PRIORITY LEGISLATION

State Budget Update

The Governor signed the long bill on May 18,2021, so we will start to see the new 667 DD waiver resources and the 2.5% provider increase in July 2021.

Medicaid Transportation bill

Alliance's bill to move Medicaid transportation services oversight from Public Utilities Commission to HCPF passed through Senate Finance this week with a unanimous 6-0 vote! The bill now moves on to Senate Appropriations. So far, it appears that it will pass through this committee too.

Sub-Minimum Wage bill

The subminimum wage bill made it unanimously through the Senate *and* through the Committee of reference in the House. Alliance is still waiting for a fiscal note in the House which will allow us to be scheduled in Appropriations before heading to the floor.

Early Intervention Evaluations

Alliance's Governmental Committee, with guidance from the EI Team, has decided to take a monitor position on the HB21-1304 that will create a new Dept of Early Childhood for the time being. Also, the bill to move EI evaluations from Dept of Educ to DHS has now been approved as a JBC bill and will likely be introduced in the coming weeks.

<u>Alliance Summit</u>: Alliance is planning on having an in-person summit in September 2021. The dates are 9/15 through 9/17 in Breckenridge. The management team is planning on attending.
