<u>Early Intervention:</u> We have signed 3 new contract providers to help us with caseloads. We got a new Social Emotional Provider, Registered Occupational Therapist, New Speech Therapy Services, and a new Billing Specialist. They are implementing a new family agreement that explains to families the expectations of families when enrolled in Early Intervention services. The no shows are why this is being implemented. Starting in May 2022 state will be taking over the local referrals across the state. There is an online referral form that can be filled out. Eight state employed Care Navigator staff will collect the referrals across the state and complete the intake process. They will coordinate the RFP process for the family to get the evaluation scheduled. Providers across the state can contact with the State to respond to RFP's. CBE has shown interest to the State that we would like to receive and respond to these RFPs. The providers that completes the evaluation can not later be the on-going provider to implement the IFSP outcomes and services.

<u>Personnel Committee:</u> Met on October 26<sup>th</sup>, reviewed policies and nothing new, just simple updates. Board made motion to approve minutes.

### **Executive Directors Report:**

<u>Minimum Wage</u>: We recently learned that rates will be increased to offset the cost to PASA's. A DRAFT RATE sheet has been sent out. "These rates are not final and will still need to go through a stakeholder process. The finalized version of these increases will go into effect 1/1/2022, concurrent with the \$15/hour requirement." Internally, Mariah, Pat, Terri and I are meeting to ensure that we are prepared.

<u>Alliance News</u>: Alliance is considering an opportunity with ANCOR. Under this proposal, all Alliance members will also become ANCOR members in 2022. More information will become available; however, this may increase membership fees for Alliance members.

<u>Guardianship:</u> The last case has been successfully transferred out of CBE. CBE no longer has any guardianship business.
